With due respect I beg to report that, depicting the following facts to the effect that, I, ASI Nirod Mahato posted under Purulia Town PS was detailed to perform Mobile duty along with force vide Purulia (T) PS GDE No- 1917 Dtd. 31.03.24 & CC No - 819/24 Today i.e.31.03.24 at about 09:00 hrs I got an information from the table officers that some persons were found creating nuisance and misbehaved with the ASI Raju Mukherjee at Barakar Road near Garikhana Durga Mandir under Purulia Town P.S. In response to the information myself along with force rushed to the spot and found that about 30/40 persons were using abusive languages to the police personnel over the issue of a pick-up van loaded with cattle debris (bones of cattle). It was revealed that the said persons were in in furious mood. When we tried to stop them and told them to leave the place they became furious and attacked us and scuffled with us. The accused persons scuffled with us used criminal force to on duty police in uniform and tried to deter us from discharging of lawful duty. Found no other alternative I seek help of other police personals from Police station and immediately ASI Bachchu Ghosh and other available police force of Purulia Town PS reached at the spot and after a vigorous effort we could able to disperse the public. By this time one unknown person had thrown one stone and broken the window shield of the said car (WB55B/4414).

Therefore I pray you to start a specific case under appropriate section of law for using of criminal force to on duty police officer during discharge of my duty with the intention to deter me and obstruct me from discharging of my duty as such public servant.
