After that the company sent me an Invoice of OLA Dealership Application Fee for approval plus 18% G.S.T. for an Indian Resident ₹25,313/- (Rupees Twenty-Five Thousand Three Hundred and Thirteen only) which I paid on 2nd June 2022. After that the company sent a Dealership Agreement Form to fill up and charged me ₹71,000/- (Rupees Seventy-One Thousand only) which I paid on 8th of June 2022.

As per terms and conditions, of minimum five scooters for free delivery the company sent me a Tax Invoice costing 40% of 5 vehicles ₹1,33,000/- (Rupees One Lakh and Thirty-Three Thousand only) which I paid on 4th of June 2022.
