Sir,

In producing herewith two seized Tractors having Registration No. WB55A/9143 and WB55B/6177 both are fitted with trolleys loaded with approximately 100 Cft sand per tractor and two arrested accused person namely (1) Aswini Jogi (35y/M) S/O Brindaban Jogi Vill- Beliapathar, near Shib Mandir P.O- Pichasi, PS- Tamna, Dist- Purulia, driver of Tractor having Reg. No. WB55A/9143 (2) Bijay Sahis (20y/M) S/O Laltu Sahis Vill- Mahara, P.O- Banbahal, PS- Purulia (M), Dist- Purulia driver of Tractor having Reg. No. WB55B/6177. Fact of the case in brief is that on 03.04.2024 I along with C/73 Gurudas Kar and C/1335 Nirmal Mahato both of Purulia Town PS were performing Action Mobile Duty at PS area vide Purulia (T) PS GDE No- 120 dated 03.04.2024 and C.C. No. 849/24. At about 12:05 hrs received source information that the above noted Tractors loaded with illegally procured sand were coming from Dabar Balarampur. After receiving such information I informed the matter to IC Purulia Town PS and as per his kind direction we had been to Goshala More, Barakar Road under Purulia (T) PS and waiting for the said Tractors and at about 12:15 hrs found that the above noted Tractors are coming from Telkal Para Over Bridge side. We stopped the said tractors and on searching it is found that the said tractors were loaded with sand and on asking drivers of the said tractors failed to produce any valid documents in respect of loaded sand as well as papers in respect of the said tractors. Accordingly I informed the matter to I/C Purulia (T) PS and as per his instruction I give them some time or chance if they can produce any valid papers in this respect in any way. After that I gave them last chance to produce relevant documents but they could not produce any documents till 12:25 hrs (03.04.2024). They also made incoherent statement in respect of possession of the said sand in their tractors which they were driving. So, it is reasonable to believe that the drivers and owners of the said tractors collected the said sand either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains. On interrogation the drivers of the said tractors confessed their guilt. As such it is every reason to believe that the drivers and owners of the said tractors Reg. No. WB55A/9143 and WB55B/6177 are mining and transporting sand illegally from riverbed. As such I seized the said tractors having Registration No. WB55A/9143 and WB55B/6177 loaded with approx 100 Cft of sand per tractor from the possession of the accused drivers under proper seizure lists duly signed by the available witnesses. Out of which approx 01 (One) K.G. Sand seized from each tractors as sample & also labeled. No public witness was available there. Thereafter, I arrested the accused drivers of above noted tractors namely (1) Aswini Jogi and (2) Bijav Sahis after observing all formalities and narrating them the ground of arrest and after observing the formalities of arrest.

I therefore pray before you, kindly lodge an FIR against the drivers namely (1) Aswini Jogi (35y/M) S/O Brindaban Jogi Vill- Beliapathar, near Shib Mandir P.O- Pichasi, PS- Tamna, Dist-Purulia driver of Tractor having Reg. No. WB55A/9143 loaded with sand (2) Bijay Sahis (20y/M) S/O Laltu Sahis Vill- Mahara, P.O- Banbahal, PS- Purulia (M), Dist- Purulia driver of Tractor having Reg. No. WB55B/6177 loaded with sand and owners of the both tractors bearing Reg. No WB55A/9143 and WB55B/6177 as per law and arrange for its investigation.
