With ref to above, my daughter Rakha Dolai
Samanta started her journey on 15.03.2024
with her minor daughter Sneha Dolai for a
new place. As per her version she could not
furnish her destination address after boarding
the train. On the basis of a complaint by her
husband Snehasish Dolai, Howrah GRP have
recovered them at Howrah Station and sent
them to the Child Welfare Committee Howrah
(Liluah) on 15.03.2024. The said Child
Welfare Committee Howrah allowed them to
move with further instruction that my daughter
will have to produce her child by
30.03.2024 to the Child Welfare Committee,
Purulia. She gave an undertaking to that
effect to them.

Till date my daughter did not return
to my residence and also did not furnish
any other address where she is staying now.
They were last seen on 15.03.2024 to the
Child Welfare Committee, Howrah. The mobile
numbers of my daughter are: 8016204750 & 8972643923.
I am in doubt that they have been
forcefully confined by some unknown
miscreants to some unknown place.
