Shyam Steel Works Private Limited, JSK-II, Village- Lachhmanpur, P.O.- Ramkanali, P.S.- Raghunathpur, Dist- Purulia, Pin-7232133, (hereinafter, referred to as "Our Company") as Sr. DGM (HR & IR) would like to bring to your kind attention about the incident that has occurred within the factory premises of our company, which is being described as below :


On 23rd of April 2024, at about 16:00 Hrs., a vehicle bearing registration no. WB39B/7847 (Model-Tata 407) entered in our plant for supply of filled LPG & Oxygen cylinders. At the time of security check at around 7:00 am on 24th April, 2024 our security personnel namely Mr. Jitendar Tiwari s/o Mr. Srimant Tiwari and Mr. Manbodh Singh S/o Sriram Singh caught 180 kg iron scrap pieces stolen and kept hidden among empty cylinders.

During the enquiry, driver of the said vehicle Mr. Ram Prasad Tantubai S/o Late Subhash Tantubai and his two helpers Mr. Pradeep Tudu S/o Rupchand Tudu and Mr. Rohit Ram S/o Satrugan Ram accepted that they had stolen the scraps while they were collecting the empty cylinder and kept them among the empty cylinders. Such acts have been occurred earlier also.


I therefore request your good self to lodge this complaint as FIR against the above named accused persons and take necessary action as per law.
