Sub: Prayer for lodging FIR against the arrested accused person namely Naran-Gorain (39Y), S/O Ananda Gorain of Vill. – Kanki Basti, PS-Santaldih Dist-Purulia.

Sir.

In producing herewith the arrested accused person named as Naran Gorain (39Y), S/O Ananda Gorain of Vill. – Kanki Basti, PS-Santaldih Dist- Purulia along with seizure – list and seized items as described below, I beg to state that on 17.04.2024 at about 16.05 hrs, while performing evening mobile duty, I received a source information to the effect that the country spirit liquor has been kept at Kanki Bazar, near STPS Gate no. 1 under this PS in the shop of above noted accused illegally, with an object to sale. I have informed the matter to I.C. Santaldih PS and as per order of I.C Santaldih P.S. I along with force left for Kanki Bazar, near STPS Gate no. 1 to workout the information with the govt. supplied kit box containing white cloth, sealing wax, seal, papers, carbons, match box, candles etc. I had been to the shop of the above noted Naran Gorain at Kanki Bazar, near STPS gate no. 1, P.S. Santaldih at about 16.15 hours. Seeing police party some unknown persons in front of the said shop were fled away. However, I could detain one among of them and asked about his identity. He disclosed his name and identity as noted above and as well as admitted that he gathered the country spirit liquor for selling and he is the owner of the said shop. However, I along with said accused started a search inside the said shop and found the following item in the said shop -

- 1) 06 (six) bottles Country Spirit style as "Dilkhush" each bottle containing 600 ML From which 01 bottle taken as sample
- 2) 15 (fifteen) bottles Country Spirit style as "Dilkhush" each bottle containing 375 ML From which 01 bottle taken as sample

I interrogated him about the purpose of the stocking and possessing such liquor. He replied it was the business of him. On repeated question he told that the person who fled away his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper seizure list between 16.35 hrs and 16.50 hrs & took up one bottle C.S. styled as "Dilkhush" 600 ML & one bottle C.S. styled as "Dilkhush" 375 ML as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, as well as selling the country spirit liquor illegally without any valid papers in the hotel has prima-facie been made out and for the interest of proper investigation, I arrested the above accused person at 16.55 hrs accordingly after maintaining all arresting guidelines.

Therefore, I pray before you to start a case under proper section of law against the accused Naran Gorain (39Y), S/O Ananda Gorain of Vill. – Kanki Basti, PS-Santaldih Dist- Purulia.
