Respected sir,

In producing herewith the certified Xerox copy of (i) warrant of arrest (ii) prayer for issued order of proclamation u/s 82 Cr PC (ii) Order of proclamation & (iv) Execution report of order of proclamation of warrant of arrest accused namely Naran Bauri @Khepa, S/O Jitu Bauri of Cinematola, PS - Santaldih, Dist. - Purulia in c/w the above noted reference, who was arrested on 18.04.2024 under the strength of warrant of arrest in c/w GR 317/23 & Santaldih PS case no. 24/23, dtd. 26.05.2023, U/S 399/402 IPC.

The fact in brief is that on 09.11.2023 Ld. Additional Chief Judicial Magistrate, Raghunathpur Court, Purulia issued warrant of arrest against accused Naran Bauri @Khepa, S/O Jitu Bauri of Cinematola, PS - Santaldih, Dist. -Purulia in c/w GR 317/23 & Santaldih PS case no. 24/23, dtd. 26.05.2023, U/S 399/402 IPC. As per your endorsement I held raid in several times to execute the warrant of arrest. But the above noted person absconding himself to avoid police arrest. Subsequently, the prayer for issuing order of proclamation U/S 82 Cr. PC against the warrantee Naran Bauri @Khepa, S/O Jitu Bauri of Cinematola, PS - Santaldih, Dist. - Purulia was submitted before the Ld. Additional Chief Judicial Magistrate, Raghunathpur Court, Purulia on 09.03.2024. The Ld. Court issued order of proclamation on the same day i.e. on 09.03.2024. After that on 16.03.2024 in compliance to the order of the Ld. Additional Chief Judicial Magistrate, Raghunathpur Court, Purulia ASI Chiranjit Pal of Santaldih I/C (BCW) under Santaldih PS to execute the order of proclamation U/S 82 Cr. PC in presence of witnesses namely (i) Jitu Bauri, S/O Lt. Kinkar Bauri of Vill. - Cinematola, PS - Santaldih, Dist. - Purulia & (ii) Alok Bauri, S/O Modiram Bauri of Vill. -Cinematola, PS - Santaldih, Dist. - Purulia duly signed by them. He also affixed one copy of said proclamation in the house (outside wall) of warrantee Naran Bauri & one copy affixed in a conspicuous place of the said locality where the warrantee was residing in presence of above noted witnesses.

Today (18.04.2024) as per source information I held raid in Cinematola Bazar and arrested the warrantee Naran Bauri @ Khepa (32 yrs), S/O Jitu Bauri of Cinematola, PS - Santaldih, Dist. - Purulia at 20.35 hrs under the strength of warrant of arrest in c/w GR 317/23 & Santaldih PS case no. 24/23, dtd. 26.05.2023, U/S 399/402 IPC after observing all arresting guidelines and brought him to PS. This is also pertinent to mention here that after the elapse of more than 30 days from the date of execution of order of proclamation U/S 82 Cr PC warrantee namely Naran Bauri @ Khepa did not appear before the Ld. Court.

Under above fact and circumstances, I, pray before you to start a specific case against the warrant of arrest accused Naran Bauri @Khepa (32 yrs), S/O Jitu Bauri of Cinematola, PS - Santaldih, Dist. - Purulia under proper sections of law.
