The OC Santuri PS Dist-Purulia

Sir,

With due respect & humble submission I ASI Jhantu Dalal of Santuri PS do here by lodge complaint against some unknown persons of Ghoramurga village under Santuri PS.

I beg to submit that today i.e on 29.04.2024 at 16:35 hrs acting on a tip off myself along with C/1010 Samir Paramanik, HG/1789 Thakurdas Bauri & LC/550 Minati Murmu all of Santuri PS left PS to work out the information vide Santuri PS C.C No-1449/24 Dtd-29.04.2024 & GDE No-1174, Date-29.04.24 with hired vehicle No-WB-31/4014 in c/w Santuri PS Case No-24/24 Dtd- 22.03.24, U/S- 341/325/308/506/34 IPC. We reached at Ghoramurga village at about 16:55 hrs and held raid in the house of FIR named accd Baniprasad Ghosh and able to intercept him. On interrogation the accused person confessed his guilt. Accordingly I arrested the above noted accused person in c/w Santuri PS Case No-24/24 Dtd- 22.03.24, U/S-341/325/308/506/34 IPC after observing all legal formalities. After that I proceeded towards PS with the arrested accused person Baniprasad @ Banipati Ghosh S/O- Lt Fatik Ghosh of Vill- Ghoramurga, PS- Santuri, Dist- Purulia. While we started for PS at that time some unknown person of Ghoramurga village tried to rescue the said accused from the grip of Police Party as well as assaulted us and restrained our vehicle by blocking the front side road of the vehicle. We several time requested them that Police is doing their duty and requested them to give way but they did not pay any heed. Resulting which myself along with force received injuries on us. After that I inform the incident at PS and called for backup force. Officer force from Santuri PS reached there. Seeing the Police party all those persons who were creating disturbance fled away and we managed to escape from the place with the arrested accused person, Then I along with my accompanied force left for Muradi BPHC with the arrested accused person. There produce the arrested accused for medical treatment as well as I along with force and LC were also treated there. After that returned to PS with the arrested accused person and put the accused in PS lock up.

Hence those unknown persons of Ghoramurga village committed offence by assaulting on duty Public servant as well as deterred the Police personnel from discharging our govt duty.

Therefore a specific case may kindly be started against those unknown persons of Ghoramurga village under Santuri PS, Dist-Purulia and arrange for its investigation.
