Respected Sir,

In producing here with the arrested accused person namely Baidyanath Murmu (32 Yrs) S/O-Sarkar Murmu of Kalipahari village, P.S - Santuri, Dist - Purulia along with 10 liters Id liquor seized under proper seizure list, I beg to submit that today (12.04.2024), I along with force while performing evening mobile duty at about 17:05 hrs received a credible source information that one person Baidyanath Murmu (32 Yrs) S/O-Sarkar Murmu of Kalipahari village, P.S - Santuri, Dist - Purulia was stocking and selling Id liquor without any valid documents from his house at Vill-Kalipahari, P.S - Santuri, Dist - Purulia.I informed to OC Santuri about this matter & as per direction, I along with force reached at his house of Baidyanath Murmu at about 18:05 hrs at Kalipahari village to work out the source information and held raid there. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person was stocking Id liquor for sell. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of Id liquor. Accordingly, I seized and labeled 'Id liquor containing 05 Ltrs each jerkin under proper seizure 02 (two) white jerkin list duly signed by the witnesses out of which one bottle sealed and labeled as sample. Then, I arrested him after preparing proper arrest memo as he committed offence U/S-46A(C) B.E. Act 1909 and supplied one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S- 46A (C) B.E. Act 1909 against the arrested accused person namely Baidyanath Murmu (32 Yrs) S/O-Sarkar Murmu of Kalipahari village, P.S - Santuri, Dist - Purulia.
