In producing here with one arrested accused namely Ashok Bauri (53 yrs) S/O Lt Nakul Bauri of Vill-Gopinathpur, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

 20 bottles DIL KHUSH country spirit, 300 Ml. each Rs/-35 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample.

I ASI Rajkumar Nandi of Adra PS do here by lodged a complaint against 01 above noted accused to the effect that today i.e. 16/05/2024 in course of special evening mobile duty as per order vide. Adra PS CC No-1220/24 dtd.16.05.24. I received information from a reliable source at about 18:35 hrs that one Ashok Bauri is selling country spirit illegally in his house at Gopinathpur Village. After getting such information I informed to I/C Adra P.S. over phone and as per his direction I along with accompanied force reached at Gopinathpur Village at about 19:05 hrs and held raid in the house of Ashok Bauri and found that the above noted accd. Person selling country spirit and after seeing the Police party, all the person fled away and said Ashok Bauri has tried to conceal him selves but we able to apprehend him. I asked him to produced valid License or valid papers in respect of selling of country spirit but he failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said Ashok Bauri engaged to sale the country spirit by illegal way. So I seized the above mentioned country spirit under proper seizure list duly sign by accused person and available witnesses. Lalso collected sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person informing him the ground of arrest. The complete process was done in between 19.05 hrs to 19.35 hrs.

I therefore pray that a specific case may kindly be start against arrested accused Ashok Bauri (53 yrs) S/O Lt. Nakul Bauri of Vill-Gopinathpur, PS-Adra, Dist-Purulia under proper section of law.
