
In producing here with one arrested accused namely Subhas Saw (51 yrs) S/O Ram Piyari Saw of Vill-Kamlasthan, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 15 bottles DIL KHUSH country spirit, 300 ML each Rs/- 35 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample.

I SI Shoumik Acharyya of Adra PS do here by lodged a complaint against 01 above noted accused to the effect that today i.e. 01/05/2024 in course of special evening mobile duty as per order vide Adra PS CC No-1120/24 dtd.01.05.24. I received information from a reliable source at about 17:45 hrs that one Subhas Saw is selling country spirit illegally in a Jhopri of Power House road near Kamlasthan. After getting such information I informed to I/C Adra P.S. over phone and as per his direction I along with accompanied force reached in a Jhopri of Power House road near Kamlasthan at about 18:05 hrs and held raid in a Jhopri and found that the above noted accd. Person selling country spirit and after seeing the Police party, all the person fled away and said Subhas Saw has tried to conceal him selves but we able to apprehend him. I asked him to produced valid License or valid papers in respect of selling of country spirit but he failed to produce any valid license or documents in respect possessing /selling the same. So it is sufficient reason to believe that above said Subhas Saw engaged to sale the country spirit by illegal way. So I seized the above mentioned country spirit under proper seizure list duly sign by accused person and available witnesses. I also collected sample from seized country spirit duly sealed and labeled by me. There after I arrest the above mentioned accused person informing him the ground of arrest. The complete process was done in between 18.05 hrs to 18.35 hrs.

I therefore pray that a specific case may kindly be start against arrested accused Subhas Saw (51 yrs) S/O Ram Piyari Saw of Vill-Kamlasthan, PS-Adra, Dist-Purulia under proper section of law.
