- a) On 10.05.2024, one of the customer of DRM Adra Branch , Shri Rajat Kurnar Mohanto S/O Shri Raghupada Mohanto, resident of Kreeng Rupsa, Flat No.3A, 3rd Floor, B.B.Roy Lane, Purulia, PS Purulia Town, District Purulia, Mobile No 7029626965, submitted a written complaint regarding some fraudulent transactions in his Savings Bank Account No. 11476905994 to BM, DRM Adra Branch
- b) On initial enquiry, it is found that the funds were transferred to Savings Bank Account of Shri Sandip Karmakar s/o Shri Uttam Karmakar, R/o Village- Manihara, PS- Kashipur, District-Purulia, who has been working as a FOS (Feet on Street), deputed by a third party recruiter namely M/s Adecco India Pvt. Ltd., having its corporate office at 73/1, 13th Floor, Summit B. Brigade Metropolis, Gorudochor, Paylo, Mahadevopura, Whitefield, Main Road, Bengaluru-560048, Karnataka It is also learnt that Shri Sandip Karmakar maintains 2 Nos of Savings account, 1 CA and 1 PPF account with SBI at different Branches. (SB A/C 20428714171 at Dhaban Branch Code 9716, SB A/C 42580652043 at DRM Adra Code 10221, CA A/C 42098759165, PPF A/C 41499033088)

Nearly an amount of Rs. 18,96,496.00 have been transferred from accounts of Shri Rajat Mohanto, A/C 11476904994 to Shri Sandip Karmakar SB A/C 20428714171.

Further scrutiny reveals that other customer's account were also debited and the amounts were transferred to Savings account of Sandip. Details of significant transactions from other customer's accounts are given below

- i) Shri SadhanBauri s/o Shri BalakBauri, A/c No.42368281435 and A/c No. 4264261153 Nearly Rs. 35,19,498.00
- ii) Shri Sarat Chandra Mahato s/o Shri Babulal Mahato, A/c No. 31764347091- Nearly Rs.5,45,036.00
- iii) Savings account of Shri Durga Das Majhi A/C 30396179775 was also debited by an amount of Rs.50000 on 27/02/2024 and transferred to savings account of Sadhan Baun A/C 42368281435. On the same day, funds were transferred from Sadhan Baun's account to Sandip's account.

Therefore, on initial enquiry an amount of Rs 60.11,030.00 have been detected as the total quantum of fraud incurred by Mr Sandip Karmakar.

 The above incidents, being a cognizable offence involving public money, we request you to register an FIR against Shri Sandip Karmakar s/o Uttam Karmakar and issue a FIR No. for our records and further reference.
