Sub: Lodging FIR against driver of car no. WB 56U/5801 for rash and negligent driving and caused injured to Prince Kumar Gupta

Sir,

I would like to inform you that on 24.05.24 morning my son Prince Kumar Gupta (29) s/o Late Deonarayan Prasad Gupta - resident of village Kumardubi Guffar Bari morh PO: Kumardubi, PS: Guffar Bari Dist: Dhanbad, Jharkhand had been going to Purulia for performing PG election duty, 2024. At around 10.00 hours while he had been proceeding towards Purulia riding on his own Bajaj Pulsar motor cycle bearing no. G178F/5776 through Purulia - Raghunathpur road and reached near Dumrakus village which falls under jurisdiction of Adra PS, Dist: Purulia, one white colour Altroz car bearing number WB 56U/5801 running in a rash and negligent manner from opposite direction dashed the motor cycle of my son, as a result he sustained grievous fracture injuries on his person specially on right leg and right hand. Soon after the incident local people rescued him and sent to Raghunathpur S. S. D. Hospital for his treatment. Thereafter, he was shifted to K M Memorial Hospital, Chas Bokaro Dist: Bokaro, Jharkhand and lastly he was shifted to Medica Hospital, Ranchi Jharkhand for better management. Now, he is under treatment in Medica Hospital, Ranchi.

Hence, I request you to kindly lodge an FIR against the erring driver of Altroz car bearing no. WB 56U / 5801 for his rash and negligent driving and caused grievous hurt to my son. Due to engagement of my son's treatment in the hospital the lodging of FIR is delayed.
