I, Sukhendu Mudi, S/O-Lt.Mritunjoy Mudi, Age-45years , AE & Station Manager, Arsha CCC,WBSEDCL, do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently, the amendment act 2007 to the effect that Mrinal Kanti Kuri, S/O- Panchanan Kuri of Village -Sirkabad, PO-Sirkabad,PS-Arsha,Dist-Purulia has committed theft of electricity U/S 135(i)(a) of electricity act 2003 subsequently amendment act 2007.

On 28.05.2024 at about 05.30 pm I, along with Rajesh Kumar,S/O- Late Gulo Ram,Junior Engineer (E),Gr-I , Arsha CCC, Gour Chandra Mahato,S/O-Lt. Bibhuti Mahato, Hg. Sr. LM, Purulia Division and Alimuddin Ansary,S/O-LI. Miyanzan Ansary Sr. Technical Support Hand, Arsha CCC went to the routine inspection at Sirkabad Village and found that Mrinal Kanti Kuri, S/O- Panchanan Kuri was enjoying electricity unauthorisedly by direct hooking from nearby LTOH Line of WBSEDCL in his premises for domestic purpose . The service connection of Mrinal Kanti Kuri, S/O- Panchanan Kuri with hooking arrangement were disconnected on the spot from nearby LTOH Line of WBSEDCL. During inspection we found the electrical load he is enjoying as 2.2KW.The inspection team left the premises of the accused person at about 05.45 pm.

Mrinal Kanti Kuri, S/O- Panchanan Kuri of Village -Sirkabad, PO-Sirkabad,PS-Arsha,Dist-Purulia has committed an offence U/S 135(i)(a) electricity act 2003(Amendment Act 2007),so you are requested to take cognizance of this complaint and treat it as FIR.
