Subject: Complain against arrested accused person Bishal Ghosh (24 Yrs), S/O-Late Shibu Ghosh of Vill+P.O- Patahensal, P.S-Baghmundi, Dist-Purulia and start a cog case under proper section of law i.e. U/S 25/27 Arms Act 1959.

In producing herewith the arrested accused person Bishal Ghosh (24 Yrs), S/O-Late Shibu Ghosh of Vill+P.O- Patahensal, P.S-Baghmundi, Dist-Purulia along with below mentioned seized items:

- (i) One improvised semi-automatic 7.65 mm pistol type iron made fire arms having slide with slide lock, trigger with trigger guard, barrel, hammer, firing pin, four side knob, iron butt with wooden plate, magazine catch & one magazine loaded with 02 (two) rounds 7.65 mm ammunition. Overall length 8.2 inch (approx), length of barrel 4 inch approx, diameter of calibre 7.65 mm.
- (ii) One Black & Red colour Honda SP 125 cc Motor Cycle bearing Regn. No. WB56R/6197, Engine No. JC83E-G-0263357 Chassis No. ME4JC831MLG116157.
- (iii) One Android Mobile Phone (Vivo T1) vide IMEI No. 862268068172592/25 & 862268068172584/25.

The fact in brief is that I SI Rana Bhakat, O/C Baghmundi PS, Dist-Purulia received a secret source information today at about 11:35 hrs that one unknown person will come from Charida side towards Baghmundi side riding on a Black & Red colour Honda Motorcycle bearing Regn. No. WB56R-6197 having possessed an illegal firearms. This refers to Baghmundi P.S. GDE No. 104 Dtd: 09.05.24.

Accordingly, I formed a team and briefed them and left PS at 11:45 hrs with Govt. vehicle vide Baghmundi PS Special CC No-308/24 Dtd- 09.05.2024 and Baghmundi PS GDE No-405 Dtd- 09.05.2024 to work out the information.

Then at about 12:05 hrs, we reached near Tata Hotel on Baghmundi-Jhalda main road (SH-04) in between Baghmundi&Chorida village and we take our position as per strategy. After that, we noticed at about 13:05 hrs that the said person is coming from Chorida side riding with said Black & Red colour Honda motorcycle bearing Reg. No-WB56R-6197.

Accordingly, I with the help of my accompany forces apprehend him. After apprehension, we disclosed our identity to him and the purpose of his apprehension and on being asked he disclosed his name and address as Bishal Ghosh (24 Yrs), S/O-Late Shibu Ghosh of Vill+P.O- Patahensal, P.S-Baghmundi, Dist-Purulia. Then, at first I requested him to search our persons and he refused. After that I along with my raid team searched him and recovered one improvised semi-automatic 7.65 mm pistol type iron made fire arms having slide with slide lock, trigger with trigger guard, barrel, hammer, firing pin, four side knob, iron butt with wooden plate, magazine catch & one magazine loaded with 02 (two) rounds 7.65 mm ammunition. Overall length 8.2 inch (approx), length of barrel 4 inch approx, diameter of calibre 7.65 mm. from his exclusive possession which was kept conceal at the back side of his waist position duly covered by his pant & shirt. After that, I asked him to produce valid licence in respect of said fire arms which has been recovered from his exclusive possession. But, he failed to produce any valid documents though sufficient time was given.

Accordingly, I seized the same under proper seizure list including the Motorcycle as noted above & one Android Mobile Phone (Vivo T1) vide IMEI No. 862268068172592/25 & 862268068172584/25. During seizure, I also prepared label in presence of witnesses duly signed by them and supply one copy of seizure list to the apprehended person. I would like to mention here that we have searched for public witness. But, nobody was interested. After seizure, I arrested the above noted apprehended person with a charge for possessing illegal fire arms after observing all norms of NHRC and Hon'ble Supreme Court of India at 14.25 hrs.

I brought the arrested person to Baghmundi PS and put him to P.S lock up after observing all Hazat formalities, supplied sufficient food and drinking water and informed Duty Officer. I also handed over the seized articles to the Malkhana Officer.

Hence, I do here by starting Baghmundi PS Case No. 79/24 Dtd: 09.05.24 U/S 25/27 Arms Act 1959 against arrested accused person Bishal Ghosh (24 Yrs), S/O-Late Shibu Ghosh of Vill+P.O- Patahensal, P.S-Baghmundi, Dist-Purulia and directed SI Alok Rana to investigate the case.
