Dear Sir,

This is to inform you that, I Sri Maruti Mahato (45), S/O - Paban Chandra Mahato, A.E. & Station Manager of Bagmundi CCC of WBSEDCL received an information to the effect that Ananda Kuiry, S/o Lt.Durga Charan Kuiry residing at Vill.- Nowadih was committing theft of Electricity at his Domestic premises by bypassing the proper registration of units by tampering the Energy meter.

Acting on this information this day 29.05.2024, I Sri Maruti Mahato alongwith Sri Anup Mondal, J.E. Gri(E) of Bagmundih CCC, Sri Subhasis Mahato, Sr.O.E. of Bagmundih CCC, Sri Indrajit Bouri, Sr.TSH of Bagmundih CCC Sri Biswajit Kumar, TSH of Bagmundih CCC had been to the house of Ananda Kuiry at the above mentioned address. He was present at his house. We contacted him and disclosed our identity to him. On being asked she allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises against the name of the consumer namely Ananda Kuiry.

Also search for local people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises was a one storied house and the meter is installed at inside the house. Immediately, a notice was prepared served upon him but he refused to sign and held the inspection.

During inspection, it was detected that, Ananda Kuiry had tampered the energy meter installed at Domestic premises bearing meter No: B4217903 in the name of Ananda Kuiry at the said premises to bypass the proper registration of units by tampering the meter circuit of the meter to commit theft of Electricity. On inspection it is also revealed that Ananda Kuiry is the actual user of the above mentioned service connection.

Immediately, on my direction Sri Biswajit Kumar, TSH of Bagmundih CCC disconnected the above mentioned service connection and removed the Energy meter bearing SI no: B4217903 after securing the installation place of the said meter from any imminent danger in future. He was shown the tampered meter but being asked he could not render any satisfactory explanation. He was informed about the offence committed by him and its penal provision.

Sri Anup Mondal, JE GR I(E) of Bagmundih CCC prepared inspection report in his presence and witnesses at the spot and load assessed as 0.650KW. The details of inspection has been mentioned in the inspection sheet attached herewith.

From the evidence so far collected from the inspection of the energy meter of Ananda Kuiry, it is well established that Ananda Kuiry was consuming Electricity illegally in his Domestic residence and for this activity of theft the WBS&EDCL has incurred huge loss of revenue.

Sri Anup Mondal, JE GR I(E) of Bagmundih CCC prepared Seizure list in respect of the said premises and meter in presence of the consumer and witnesses at the spot.

The inspection was held between 04:50PM to 05:10PM today after observing all legal formalities.

It is well evident that accused Ananda Kuiry, S/O Lt. Durga Charan Kuiry, of Vill.- Nowadih has committed offence punishable U/S 135(1)(b) & (1)(d) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR
