Respected Sir,

In producing here with one arrested accused person Nimai Rajak (35 yrs) S/O- Lt. Keshab Rajak of Vill- Rangamati, PO-Rangamati, PS-Arsha, Dist. Purulia along with seized 13 bottles country spirit style as 'DIL SE' each bottle containing 600 ml (MRF each Rs-55/-) (details of seized articles are mentioned in attached seizure list), to the effect that today on 01.05.2024 I SI Shyamalendu Chowdhury along with C/1464 Bhagyadhar Patra & C/2419 Kanai Soren were engaged in mobile duty vide Balarampur PS CC No-1623/2024 dt- 01.05.2024. In course of mobile duty at about 19:15 hrs I received a telephonic information from a reliable source that one person have stocked some illicit liquor at beside the Sagar Hotel beside the Tata Purulia NH-32 which is situated near Berma village under Balarampur P.S & selling the same to innocent people for his personal gain. Accordingly, I informed to O/C Balarampur P.S. regarding this matter and as per his direction I along with force left for beside the Sagar Hotel to work out this information. Thereafter as per source at 19:45 hrs we reached at beside the Sagar hotel, I along with force held raid beside the Sagar Hotel.

During search with the help of accompany with force, we found that the said person is selling ID liquor beside the Sagar Hotel. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said ID liquor. Accordingly, I seized the following articles from the possession of accused person as follows- 13 bottle country spirit style as 'DIL SE' each bottle containing 600 ml (MRF each Rs-55/-) after preparing proper seizure list duly signed by the witnesses and labelled. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(c) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(c) B.E. Act against the arrested accused person Nimai Rajak (35 yrs) S/O- Lt. Keshab Rajak of Vill- Rangamati, PO-Rangamati, PS-Arsha, Dist. Purulia to start a cog case U/S 46A(c) B.E. Act and arrange for its investigation.
