Akshay Saraf and Sumit Saraf assold to my husband and both are pressed neck of my husband and when I shouting at the time they are go away. They are went to murdered to my husband. we stop one murdered to me and my family member.

I therefore request you to please take an necessary steps against the aforesaid person according to law.
