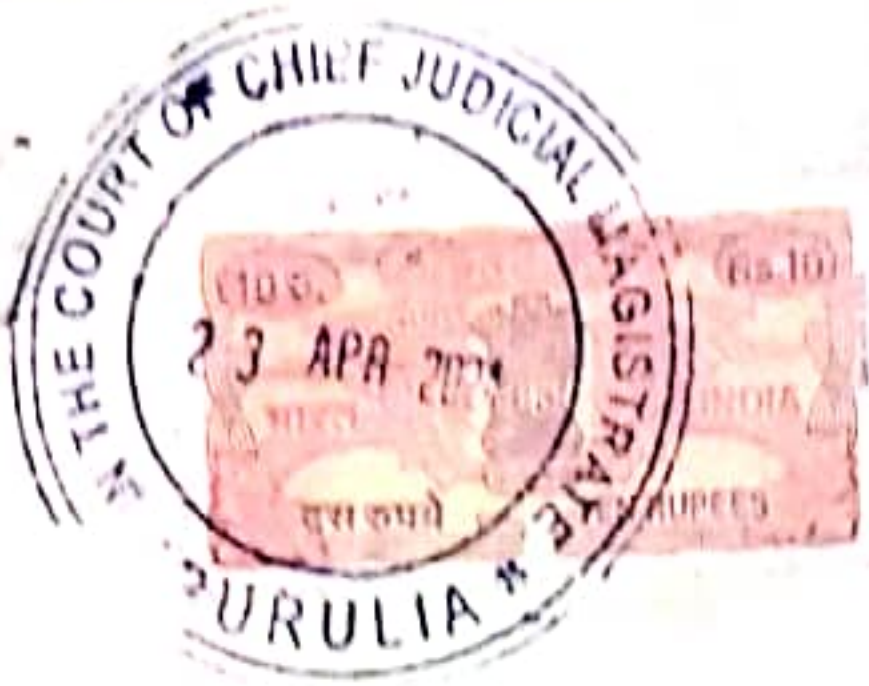

Fact of the case in brief :-

1. That in the month of April 2021 i.e. On 21/04/21 the accused no 1 and 2 taking the advantage of the complainants' unemployment , they fraudulently allured and assured the complainant that one high ranked officer of the Govt. Of West Bengal in the Department of Health and Family welfare named Manas Das who is closely known to them is providing appointment as Group – D Staff in the Health Department Govt. Of West Bengal on taking Rs 600000/- per candidate and on influencing the complainant they assured him to get the job took Rs 100000/- as advance money cash in two instalments of 50000/- each on 02/05/21 and 05/05/21 from the complainant at his house along with all the copies of his educational records etc.
2. That on 08/05/21 a text message was sent to the complainant through gmail < itcell.hfwdwb@gmail.com > stating that documents of the complainant have successfully verified for his application for the post of Group D General Staff in Health and Family welfare Department Government of West Bengal and the complainant was asked to Report at Bishnupur Sub- Divisional Hospital at Rasik Gang , Bishnupur West Bengal 722122 on 10/05/21 and he went there and met some persons there and on 11/05/21 another text message from the same gmail was sent to him informing that documents of the complainant have been forwarded to Additional Chief Secretary of West Bengal Health & Family Welfare Department asking the complainant to send his medical efficiency report and he sent it accordingly and on 17/05/21 through Whats App an appointment letter was sent to the complainant with logo and seal of the West Bengal Health Recruitment Board containing the signature of Manas Das (Sarkar) as Add. Deputy Secretary West Bengal Health Department and on 19/05/21 another message was sent to the complainant stating he has been appointed for the post and so that he may Join at Bishnupur Sub- Divisional Hospital Bankura on 21/05/21 , accordingly he went there and he was assured by some persons there in that Hospital that further letters

would be sent to him and so that he may attend on that occasion and on good faith the complainant came back to his home and on 24/05/21 the accused no 1 and 2 came to house of the complainant at village Sankhari and demanded the rest amount of Rs 500000/- immediately, pressurised him to send the amount in the Bank Account of the accused no 3 through NRTGS (NEFT) accordingly under pressure the complainant through the Bank Account of his father maintained by him in P.N.B. Barrah Branch Account no 1317101092248 sent Rs 500000/- by NRTGS (NEFT) in favour of the accused no 3 in his Account maintained by him at SBI Kesiapada Branch West Medinipur Account no 39876412828 IFSC Code SBIN 0008329 on 24/05/21. The said accused persons most illegally taking the disadvantage of un-employment of the complainant fraudulently misappropriated the money by circulating manufactured false documents defrauded the complainant and he could not get any employment as assured by them.

3. That on several occasion the complainant tried to contact the accused persons but all the times they misled the the complainant by giving false information and lastly on 30/01/24 the accused persons flatly denied about the matter, accordingly on 02/05/24 the complainant informed the incident before the I.C. Barabazar P.S. and on 06/02/24 informed the S.P. Purulia but no action has yet been taken against the accused persons, hence the complainant files this petition before the Ld. Court.

It is prayed therefore that your honour would be graciously pleased to sent this application to the I.C. Barabazar P.S treating the same as an F.I.R. as provided U/S 156 (3) Cr.P.C. for investigation with a direction to start a case against the accused persons
