Subject: Complaint against Rabi Mahato (25 Yrs), S/O- Pandab Mahato of Vill- Murgadih, PS - Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accused person Rabi Mahato (25 Yrs), S/O- Pandab Mahato of Vill- Murgadih, PS - Boro, Dist - Purulia with two white colour jerkin loaded with approx 24 (Twenty Four) ltrs. ID Liquor and 01 (one) plastic bottle loaded with 01 ltr. ID Liquor from there seized as sample as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that on 21.05.2024 at about 18.45 hrs. I received a credible source information while I was engaged in Spl Mobile duty vide Boro PS SPL.C.C No.-116/24 Date- 21.05.2024 that one person namely Rabi Mahato (25 Yrs), S/O- Pandab Mahato of Vill- Murgadih, PS - Boro, Dist - Purulia is selling Illicit Distil liquor (CHOLAI MOD) without any valid license in his house at Murgadih village under Boro PS. Accordingly, I informed the said information to O/C, Boro P.S and as per his direction, myself along with C/206 Jhantu Khan, C/ 291 Sandip Gorai both are of Boro P.S, Dist-Purulia left for Murgadih village to work out the said source information and found that the said person is selling I.D liquor (CHOLAI MOD) to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person namely Rabi Mahato (25 Yrs), S/O- Pandab Mahato of Vill- Murgadih, PS - Boro, Dist - Purulia . On being asked, he failed to produce any valid documents/ License in respect of selling of said Illicit Distil liquor (CHOLAI MOD). Accordingly, I seized and labelled all the Illicit Distilled liquor (details in attached seizure list) i.e approx 24 (Twenty four) ltrs. ID Liquor and 01 (one) plastic bottle loaded with 01 ltr. ID Liquor from there seized as sample as produced by the said accused Rabi Mahato (25 Yrs), S/O- Pandab Mahato of Vill- Murgadih, PS - Boro, Dist - Purulia and prepared proper seizure list duly signed by the seizure witnesses. Then, I arrested him at 19.35 hrs after maintaining all legal procedures regarding arrest as per Cr.P.C, NHRC guide lines and as laid down by Hon'ble Supreme Court as he committed offence U/S- 46A (c) Bengal Excise Act. 1909. I would like to note down here that after local enquiry the arrest was made because a cognizable offence was being committed in presence of a Police Officer.

Under the above circumstances and fact, I therefore pray that a specific case may kindly be started U/S 46A(C) Bengal Excise Act. 1909 against the arrested accused person namely Rabi Mahato (25 Yrs), S/O- Pandab Mahato of Vill- Murgadih, PS - Boro, Dist - Purulia and arrange for it's investigation.


