






#### The above name complainant begs to state as follows:

- That the complainant is the permanent resident of village &
   P.O. Kulgora, P.S. Hura, Dist-Purulia.
- 2) That the complainant was given in marriage with the accused no-1 Suraj Kumar Pandey on 04/02/2011 as per Hindu Rites and Customs as prevalent in their community and also by observing the formalities like putting on vermilion, exchange of garlands, Home etc and the said marriage is still subsisting, and in their wedlock one son namely Prem Kumar Pandey was born.
- That after marriage as per demand of the accused persons, the father of the complainant had to pay a cash of Rs. 1,50,000/-,
  Golden ornament 3 bhories and Silver ornament weighing 2
  ½ bhories, and various type of articles.
- 4) That after marriage the complainant went to her matrimonial house and started her matrimonial journey with the acused no-1 Suraj Kumar Pandey as husband and wife along with other in-laws of the family.






- the accused persons behaved well and good. For about 6 months from the date of marriage the marriage of the complainant leading their conjugal life happily, but thereafter the accused persons without any laps on the part of the complainant inflicted torture both mental and physical. However, bearing all such torture continued the matrimonial house of the complainant with the accused no-1 i.e. the husband of the complainant and other inmates of the family, by that time the complainant have blessed one daughter and two sons, but the above noted persons never change their mind, but persistent torture was continued upon the complainant.
  - That thereafter the accused persons started all sorts of inhuman as well as mental torture upon the complainant, she was also not provided proper food and clothing even not provided medicine in course of her illness.
  - 7) That in such circumstances the accused persons asked the complainant to bring a cash of Rs. 1,00,000/- from her father

as further dowry, contrary to that the accused person will not allow the complainant to stay in their house. When such illegal demand was not fulfilled then the accused persons assaulted the complainant and also press her neck and also by other process tried to kill the complainant during staying at her matrimonial house.

- 8) That on 08/02/2024 the complainant was driven out from her matrimonial house after snatching her eldest son and daughter and also snatch all her belongings and Stridhan etc. and the complainant finding no other alternative came back at her paternal house with her youngest son Prem Kumar Pandey.
- 9) That it is very pertinent to mentioned here that, prior to that several meeting was held but the accused persons never changed their behavior as they promised in the said meeting.
- 10) That meanwhile the husband of the complainant contacted second marriage with one Rubi Pandey at Dhanbad during substance of the marriage with the complainant.



- 11) That the accused persons committed various offences punishable under the Indian penal code for which they are deserved to be punished under the law.
- P.S. against the accused persons but the said Officer-in-charge did not taken any legal action then the complainant lodged another complaint to the Superintendent of Police,

  Purulia but with same fate, then the complainant is under compelling circumstances is filing this complaint before the Ld. Court for appropriate reliefs under the law.

It is therefore, prayed that your honour may be pleased to sent the petition of complaint to the Officer-in-charge Hura P.S. for treating the same as FIR under section 156(3) for investigation.
