Sir,

I, SI Shantimoy Nandi along with force returned to PS with 01 (one) arrested accd. person namely Rajesh Oran (32 Yrs) S/O Lt. Gondra Oran of Vill+PO- Balumath, PS- Balumath, Dist-Latehar (Jharkhand) driver of truck having Registration No- JH02AX-1815 along with seized article i.e. one truck having Registration No- JH02AX-1815 loaded with approx 07 MT of steam coal under proper seizure list and produced before your good self.

The fact in brief is that today (07/05/2024) myself along with force namely C/814-Sushabhan Goswami, NVF/843-Bibeknanda Mahato were performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 292/24 Dated- 07/05/2024 in consonance with Jhalda PS CC No- 1849/24 Dated- 07/05/2024. During my evening mobile duty, at about 18:05 hrs, received a tip off that 01 (one) truck loaded with stolen steam coal was coming from Jharkhand side along Gola Road towards Jhalda. Subsequently, I informed to you and the duty officer and asked him to note down GDE vide No 302/24 dated 07/05/2024. Consequently, as per your kind order I started Naka at near Kansra no entry point by placing the guardrail on the Gola Road. Thereafter I saw the 01 (one) truck was proceeding towards Mosina more. Consequently, we intercepted the said truck at Naka checking point at about 18:45 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on that truck tried to flee away. After hot chase we managed to apprehend him and the truck having Registration No- JH02AX-1815 loaded with approx 07 MT of steam coal. On being asked, the rider of the truck disclosed his identity as noted in the supra. I asked the driver of the truck to produce the valid documents in respect of the truck as well as the loaded steam Coal. But he could not able to produce any kind of documents in respect of the said truck and the loaded steam Coal. We waited for reasonable time but none came to spot to produce any documents in respect of the said truck loaded with steam Coal. So it is reasoned to belief that the driver & Owner of the said truck in cahoots with others procured the said steam coal from Jharkhand state by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo, So I seized the said truck having Registration No- JH02AX-1815 loaded with approx 07 MT of steam coal after preparing proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Rajesh Oran (32 Yrs) S/O Lt. Gondra Oran of Vill+PO- Balumath, PS- Balumath, Dist-Latehar (Jharkhand) after informing him the ground of arrest and issued Memo of Arrest against him. Thereafter, I brought the said seized articles to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the accused person namely Rajesh Oran (32 Yrs) S/O Lt. Gondra Oran of Vill+PO- Balumath, PS- Balumath, Dist-Latehar (Jharkhand), (ii) The owner of the said truck having Registration No- JH02AX-1815 as they committed offence U/S- 379/411/413/414/120B of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.
