Sir,

I, ASI Subhas Ch. Mahato along with force return to PS and brought under seizure 02 (two) no's of sand loaded tractors as (i) One Green colour tractor having Engine No- PY3029D499419 attached trolley loaded with (approx 100 cft) sand & (ii) One Red colour tractor having Registration No-WB-55/7627 attached trolley loaded with (approx 100 cft) sand. The fact in brief is that to-day (07/05/2024) I along with force namely i) C/1221-Yudhistir Kumar & ii) HG/1827- Sahadeb Singha were performing Special mobile duty at Jhalda PS area vide Jhalda PS GDE No- 303 Dated- 07/05/2024 in consonance with Jhalda PS CC No- 1851/24 Dated- 07/05/2024. During my evening mobile duty at 18:45 hrs I have received a credible source information that two above Tractors is coming from jargo more side towards Jhalda along Jhalda Bagmundi road. Subsequently, I informed you and as per your kind order, I placed Naka at Kuki under Jhalda PS, Dist-Purulia to work out this tip off and started Naka Checking after placing proper guard rail on the road. Thereafter I saw two tractors was proceeding Jargo More side towards Jhalda along Jhalda Bagmundi road. Consequently, we intercepted the said Tractors before Naka checking point on 07/05/2024 at about 19:15 hrs. and found that said vehicles as well as loaded sand each as identical as I received prior information. But seeing the Police, the drivers of the said Tractors fled away leaving the Tractor on road before Naka checking point at Kuki more under Jhalda PS, Dist- Purulia. We tried to chase them but in vain. After that we searched the said Tractors for valid documents but did not find any valid documents in respect of loaded sand in the tractors. We also waited for some times but nobody came there. Hence I seized the said 02 (two) tractors (i) Green colour tractor having Engine No- PY3029D499419 attached trolley loaded with (approx 100 cft) sand & (ii) One Red colour tractor having Registration No-WB-55/7627 attached trolley loaded with (approx 100 cft) sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter I brought the said tractors to Jhalda P.S. As such there is every reason to believe that the driver and owner of the said seized tractors, attached with trolley with loaded sand each, are transporting sand illegally without any valid document in clandestine manner.

Therefore, I pray before you that a specific case against the respective driver and owners of seized said 02 (two) tractors (i) One Green colour tractor having Engine No- PY3029D499419 attached trolley loaded with (approx 100 cft) sand & (ii) One Red colour tractor having Registration No- WB-55 /7627 attached trolley loaded with (approx 100 cft) sand may kindly be started under proper section of law and arrange for its investigation.
