


1) That, the Complainant is the owner, possessor and title holder of R.S/ L.R Plot No. 3634 of Mouza Jhalda, and the said property belonged to his elder sister Majda Khatun and she gave the said property to the Complainant by Registered Deed but Accused Person i.e. Dil Mahammad Khan in collusion with some persons prepared some forged documents including a deed being No.8015 dated 16.01.2022, and when the Complainant obtained an information from the Additional District Sub-Register Office, Jhalda on 28.02.2024 they gave result 'No record found' and the Complainant has lodged complaint before I/C Jhalda P.S and also B.L.&L.R.O. Jhalda-I at that time the on the same day the Accused Person was present and he admitted that the said deed is not genuine and the said deed is also collusive, and the Complainant obtained certified copy one mutation case being No. MN/2022/1413/1403 dated

25.01.2022 and the B.L.&L.R.O. Jhalda-I without any proper deed allowed the said mutation case in favor of the Accused Person, and the Complainant lodged complaint before the B.L.&L.R.O. Jhalda-I and B.L.&L.R.O. Jhalda-I has advised to the Complainant to prefer an appeal before the D.L.&L.R.O. Purulia and due to I have no extra source of income so I am not in position to prefer an appeal but due to Dil Mahammad Khan i.e. Accused Person gave out threats to the Complainant again and again that if the Complainant lodged any complain or file any case before any Concern Authority or Jhalda Police Station then he will take step against the Complainant and also gave out threats that he will murder to the Complainant at any point of time and also throwing vulgar language to the Complainant and family members.

2) That the Complainant has lodged complain before the I/C Jhalda Police Station on 13.03.2024 by Register Post and I/C Jhalda P.S has received the said complaint on 14.03.2024, and the Complainant also lodged complaint before the S.P. Purulia on 11.03.2014 but both concern authorities did not take step till now so the Complainant file this case against the Accused Person for relief

It is prayed, that your Honour would be pleased to admit the petition and to send this petition to I/C Jhalda P.S. and directing him to treat this petition as F.I.R. against the accused persons and also pass necessary order which will deemed fit and proper.
