Sir,

In producing here with arrested accused person namely Sekh Dastugir (29) S/O Sekh Hanif of Bagandih, Jhalda Ward No-7, PS-Jhalda, Dist-Purulia and seized articles Two (02) Motor Cycle i.e. (1) One Black colour Silver Border Hero Honda Splendor Plus having Chassis No. MBLHA10CGGHF59916, Engine No- HA10ERGHF59096 & (2) One Black colour Passion Pro having Registration No. JH05H 1495, Chasis No. MBLHA10BJFHD38453, Engine No- HA10ETFHD38854 under proper seizure list, I beg to lodged this complaint, that today at 21:25 hrs I received a source information that one person is going towards Jhalda side from Tulin side by a Motorcycle and he procured the said Motorcycles by means of Theft. Accordingly, I informed the matter to I/C Jhalda PS and as per his direction I along with ASI- Thakurdas Kalindi & C/ 331- Mansaram Kumar left for working out the information. At around 22:25 Hrs we detained the suspected person at Birsha more. On interrogation he revealed his identity i.e Bagandih, Jhalda Ward No-7, PS-Jhalda, Dist-Purulia and he also confessed that he procured the Motorcycle by means of theft and hence he had no valid documents of the said Motorcycles from his possession as stolen property and arrested him.

On further interrogation he also confessed that one stolen Motorcycle was kept at his house at Bagandih, Jhalda Ward No-7, PS-Jhalda, Dist-Purulia. Accordingly leading his confessional statement and I recovered & seized one Motorcycle from his house as shown and identified by him.

Hence, I pray that a specific case may kindly be started against him U/S 379/411 IPC and arrange for its investigation.
