In producing herewith arrested accused persons namely (i) Bibek Paramanik (24) S/O Ratan Paramanik, (ii) Rahul Paramanik (29) S/O Ratan Paramanik, (iii) Nidhu Kuiry (42) W/O Bhaban Kuiry, (iv) Sulachana Bagti (28) W/O Dulal Bagti, (v) Chandana Dhibar (28) Raju Dhibar, (vi) Sabitry Bagti (30) W/O Joydeb Bagti, (vii) Tilaka Bagti (50) W/O Natan Bagti all of Jhalda Anandabazar, Ward No-11, PS-Jhalda, Dist-Purulia under arrest memo and inspection memo & seized articles (i) Two bamboo sticks, (ii) Four brickbats and (iii) Four empty bottles under proper seizure list, I would like to draw your kind attention that today (22/05/24) at 09:25 hrs received a telephonic information from Jhalda BPHC that one patient namely Samir Dey (25 years) S/O Asim Dey of Jhalda Ward No-11, PS-Jhalda, Dist-Purulia was brought to Emergency of Jhalda BPHC at 06:40 hrs and he died at 07:50 hrs. After breaking out the information of death of Samir Dey, the relatives and local persons started assembling there and they were showing agitation in front of Emergency. There was a chance of serious law & order issue there. Accordingly, I informed the matter to IC Jhalda PS & as per his direction I along with ASI Baban Pathak, ASI Subhas Mahato, SI Sunil Banerjee, LHG/1963-Chandana Kundu C/3112-Abhijit Bera, C/3402-Bapataran Seth, C/3452-Md. Mujaffar Hussen, C/3205-Purna Nanda Roy & C/3032-Somnath Dey left for Jhalda BPHC to work out the information.

We reached there at 09:45 hrs and found that around 100 persons including a good number of ladies assembled there and they were showing agitation in front of Emergency gate of the hospital, which causes hindrance to the Emergency duty of hospital staff as well as create panic upon the patients. We tried to pacify them but they were growing more agitated. They were trying to enter into the Emergency to manhandle the Doctors & staffs but we somehow tackled them. The gathering started increasing. At 10:15 hrs I informed IC Jhalda PS about the situation and sought for reinforcement. At 10:35 hrs SDPO Jhalda along with IC Jhalda PS & force including lady constables arrived there.

We requested the mob to get disperse but they became violent. All of a sudden at around 11:45 hrs. they started pelting stones, bottles etc aiming at on duty Police personnel. Finding no other alternative to control the situation we chased them and they started running away. I with the help of the accompanying officers, force & LC detained the above noted accused persons who on interrogation confessed their guilt & revealed their identity and accordingly I arrested them after observing all the formalities regarding arrest. I also seized (i) Two bamboo sticks, (ii) Four brickbats and (iii) Four empty bottles from the PO in presence of the witnesses as well as arrested accused persons. Due to their such attack ASI Baban Kr. Pathak sustained serious bleeding injury and LHG/1963-Chandana Kundu, got injury and both were admitted at hospital. C/3112-Abhijit Bera, C/3402-Bapataran Seth, C/3452-Md. Mujaffar Hussen, C/3205-Purna Nanda Roy & C/3032-Somnath Dey were also injured and got treated at hospital.

Hence, I would like to request you started a specific case under proper section of law and arrange for its investigation.
