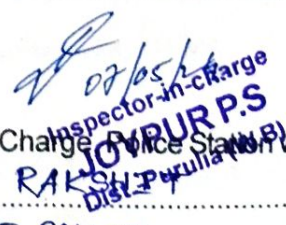

The humble petition on behalf of the complainant:-

Most respectfully sheweth:-

1. That your petitioner is rightful owner of the land bearing RS/LR plot nos.710, 723, 726, 727, 729 of mouza Kusumtikri, J.L.No.79, and RS/LR plot nos.234,235,431 and 564 of mouza Velaidih, J.L.No.67, under P.S.Joypur, Dist. Purulia and he obtain the said land by judgement and decree from the court of Civil Judge,Purulia. The accused persons have no right, title and possession over the case land.
2. That on the date of occurrence i.e.on 8.3.24 all the accused persons being armed with weapons unlawful assembly with an intention to commit murder and also damage the ail of cultivation land of the complainant forcibly and illegally entered into the land and damage the ail and try to disposses the complainant. The complainant sustained loss of Rs.2 4000/-only. The witness named above saw the incident and the matter was also reported to them.
