Lodging of F.I.R of theft of Electricity against Tapan Goswami, S/o Dayamoy Goswami at his Domestic premises at Ghat Rangamati , Kashipur,

P.S.-Kashipur and thereby committed an offence punishable U/S 135(1)(b) of Electricity Act 2003 amended in 2007.

Dear Sir,

This is to inform you that, I Sri Somnath Burman S/O – Sri Niranjan Burman, A.E. & Station Manager of Kashipur CCC of WBSEDCL received an information to the effect that Sri Tapan Goswami S/O – Dayamoy Goswami residing at Ghat Rangamati, Kashipur was committing theft of Electricity at his Domestic premises by bypassing the units by passing the incoming cable of the Energy meter.

Acting on this information this day 02.05.2024, Undersign alongwith Sri Partha Chakraborty, D.E.(E) of Purulia Region Office, Sri Dayamay Mahato, Sr. TSH of Purulia Region S & LP Unit and Sri Gotirmoy Dass, JE(E), Kashipur CCC had been to the house of Sri Tapan Goswami at the above mentioned address. He was present at his house but refuse to sign. On being asked he allowed us to inspect the Energy meter of WBSEDCL installed at his domestic premises against the name of the consumer namely Tapan Goswami i.e. we also search for head people as witnesses during our inspection of the Energy meter of the said premises but none came forward though some local people gathered there. The premises were a one storied building. Immediately, a notice was prepared but the consumer refused to signed and held inspection.

During inspection, it was detected that, Tapan Goswami, S/o Dayamoy Goswami had bypassed the energy meter installed at Domestic premises bearing meter No: BB1017683 in the name of Sri Tapan Goswami at the said premises to bypass the electrical units bypassing the incoming cable of the meter circuit of the meter to commit theft of Electricity. Inspection also revealed that Tapan Goswami was the actual user of the above mentioned service connection.

Immediately, on direction of Sri Partha Chakraborty, D.E.(E) of Purulia Region Office disconnected the above mentioned service connection of the Energy meter bearing Si no: BB1017683 for any imminent danger in future. Sri Tapan Goswami was shown the bypassing arrangement of the meter but being asked he could not render any satisfactory explanation. He was informed about the offence and its penal provision.P.T.O.

The inspection was held between 12.20 PM to 12:45PM today after observing all legal formalities.

I is well evident that accused Sri Tapan Goswami, S/o Dayamoy Goswami of Ghat Rangamati has committed offence punishable U/S 135(1)(b) of Electricity Act 2003 amended in 2007.

You are requested to take cognizance of this complain & treat it as FIR .
