Sir,

In producing herewith with the accused person namely Prakash Mahato (27) S/O-Dharanidhar Mahato of Vill-Kenda, PS-Kenda, Dist- Purulia along with seized articles (1) 15 (Fifteen) bottles of country spirit brand DIL KHUSH containing 600 ML of each bottle in sealed condition (2) 16 (Sixteen) bottles of BEER brand Haywards 5000 containing 500 ML (3) 07 (Seven) bottles of BEER brand Budweiser Magnum containing 650 ML (4) 15 (Fifteen) bottles of BEER brand Budweiser Magnum containing 330 ML of each bottle in Sealed condition (3) One big size of old nylon bag under proper seizure list.

I beg to report that today (21.05.2024) at about 21.25 hrs while I along with force were performing night mobile duty at Kenda area under Kenda PS, Dist-Purulia, received a secret source information from my reliable source that the above noted person is engaged in selling of country spirit in Ban Palashi line hotel under PS Kenda, Dist- Purulia. Immediately I informed the matter to O/C Kenda P.S then as per his direction I SI Biswajit Banerjee along with force rushed to the spot. On arrival at In Ban Palashi line hotel under PS Kenda, Dist- Purulia at about 21.55 hrs and on seeing the Police vehicle one person started fleeing from the spot. However after a hot chase we were able to apprehend him and found he kept total (1) 15 (Fifteen) bottles of country spirit brand DIL KHUSH containing 600 ML of each bottle in sealed condition (2) 16 (Sixteen) bottles of BEER brand Haywards 5000 containing 500 ML (3) 07 (Seven) bottles of BEER brand Budweiser Magnum containing 650 ML (4) 15 (Fifteen) bottles of BEER brand Budweiser Magnum containing 330 ML of each bottle in Sealed condition. On primary interrogation he disclosed his identity as noted above and admitted before Police that he is engaged in selling country sprit and Beer illegally. The apprehended person could not produce any valid license/order for selling country spirit and Beer. Finding no other alternative I arrested him after observing all formalities of arrest and seized the above noted articles under proper seizure list duly signed by the witnesses and taken one bottle of each item as sample and labeled the same.

Hence he is liable of an offence under section 46A(C) of Bengal Excise Act, 1909.

Under the above facts and circumstance a specific case under 46A B.E Act 1909 may kindly be registered against Prakash Mahato (27) S/O-Dharanidhar Mahato of Vill-Kenda, PS-Kenda, Dist-Purulia and arrange for its regular investigation.
