I ASI Janardan Kumar of Kotshila PS, Dist- Purulia producing herewith one arrested accused person namely Gholtu Sing Mura (60 yrs) S/O-Lt. Raghunath Sing Mura of Vill-Ukma (Mohulpara), PS-Kotshila, Dist-Purulia along with seized articles i.e. (1) One white colour jarican containing approx 14 Ltrs. ID Liquor (Cholai) (2) Approx 500 ml ID liquor as sample which was collected from seized articles from Sl. No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (27.05.2024) during evening mobile duty vide Kotshila PS C.C No. 1684/2024, Dated 27.05.2024 acting upon a secret source information myself along with C/699 Biswajit Banerjee and C/1362 Fatik Ch Roy both are of Kotshila PS conducted raid in the house of accused person Gholtu Sing Mura at about 20:05 hrs and found that the above noted person was keeping and selling of ID liquor (Cholai) to the others in his own house. Seeing the Police party he tried to flee way but we managed to apprehend the above noted accused person. On being asked he failed to produce any valid license /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing approx 14 Ltrs. ID Liquor (Cholai) 2) Approx 500 ml ID liquor (Cholai) as sample which was collected from seized articles from SI No- 01 & kept in a bottle in his possession under proper seizure list in presence of witnesses and duly signed by them in between 20:25 hrs to 20:55 hrs and also arrested the above noted accused person at 21:05 hrs after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labeled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Gholtu Sing Mura (60 yrs) S/O-Lt. Raghunath Sing Mura of Vill-Ukma (Mohulpara), PS-Kotshila, Dist-Purulia under proper section of law.
