Respected sir.

It is for your kind attention that our company situated at bonra is dealing with metals & their products which are costly in nature so we are deploying security personnel for taking the patrolling rounds inside and outside at day and night to prevent any theft or suspicious activity on daily basis.

On the day of 26th Apr, 2024 at 09: 00 PM when our security guards were on daily routine basis night round outer side of the Periphery of the factory namely Akshay Gorai S/O Late Manik Gorai, Bivas Kalindi S/O Nimai Kalindi and Prodip Maji S/O Ashok Maji near the Gate NO.4 of our Plant towards the Pond which is situated by the road towards to Moutha Village. Suddenly 05 to 07 Local villagers ambushed our guards and beaten them badly by Lathis and used Fist and Blow to them. After raising a hue and cry by our other security guards they left them and ran away from the spot. Due to this suddenly attack to our security guard, got injured badly and admitted to the Harmadi Rural Hospital about 10: 00 Hrs. to 10: 30 Hrs. But as per the health condition Akshay Gorai was referred and admitted to Raghunathpur S.D. Hospital, Purulia and one guard Kalindi was given injection and treatment to recover. The ambush was so Planned that security guard namely Akshay Gorai was just Half Dead and admitted to the Hospital till 30th Apr, 2024.

As i (Bablu Hansda) was security in charge on duty that day and I am also a local Native and as per my knowledge 02 or more villagers of Moutha Village who had already threatened our security guards in the past also, mainly suspects Rabi kisku S/O Ras kisku and Ganesh Kisku S/O Mangal Kisku can be involved in this Ambush attack as per their suspicious activity during the past.

As it is a serious concern for security of our Men & Material of our Plant, due to this fatal incident put a dent of fear in security guards and if this type life threatening attack will also happen in the future, then it is impossible and Hercules task to run the Plant peacefully.

So, it is humble request to take the appropriate investigation of this incident and lodge the F.I.R against the Suspects who were involved and accused for the same, so that they should have a fear of law.

REASON FOR DELAY - Security guards were admitted in hospital and after discharge gone to their home so waiting for their recovery to record statement.
