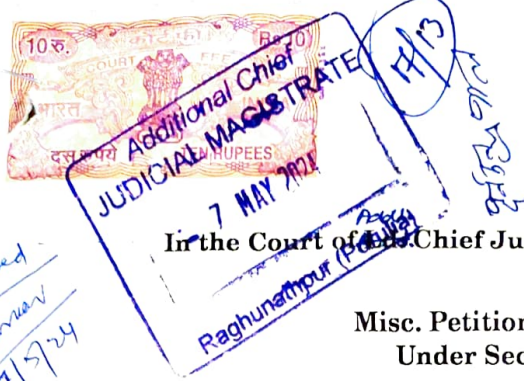

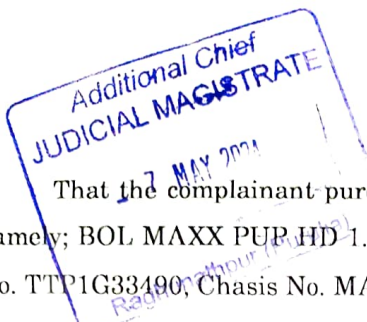
The complainant named above most respectfully beg to state as follows :-

That thereafter the matter has been reported to the O.C, Neturia Police Station and to the Superintendent of Police, Purulia but till date no case has been started regarding the aforesaid incident.

That a through investigation is required by a specialized agency for unearthing the truth and to recover his stolen four wheeler car, otherwise truth would not see the light of the day.

Under the aforesaid circumstances, It is prayed that your honour may be pleased to send the petition of complaint to O.C, Neturia Police Station under section 156 (3) Cr.P.C with a direction to cause investigation into the matter after treating the petition of complaint as FIR and do justice thereby.
