Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith arrested accused person namely Kalicharan Mondol (44 yrs) S/O-Lt. Gopal Mondol of Vill-Gopalpur, PS-Neturia, Dist-Purulia with seizure of 27 pcs sealed bottles of Dil Se Country spirit containing 375 ml each (MRP @ Rs. 35/-) which were seized under proper seizure list.

I beg to submit that today (01.05.2024) while I, ASI Mukesh Bauri, along with force were performing anticrime evening mobile duty vide Neturia PS GDE No-23 Dt. 01.05.2024 & CC No-1205/24 Dt. 01.05.24 and acting on source information after consulting you at about 19:45 hrs reached at village Gopalpur and held raid in the hotel of Kalicharan Mondol (44 yrs) S/O- Lt. Gopal Mondol of Vill-Gopalpur, PS-Neturia, Dist-Purulia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand he failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A (c) B.E. Act and he was arrested U/S-67 BE Act and also 27 pcs sealed bottles of Dil Se Country spirit containing 375 ml each (MRP @ Rs. 35/-) which were seized under proper seizure list duly signed by witnesses and out of it labeled 01 (One) bottle at the time of seizure. During arrest, I followed all the guidelines of Ld. Apex Court, NHRC & WBHRC and the ground of arrest was duly notified and informed his relative, issued arrest memo u/s-50 Cr. P.C. and handed over a copy of the same to arrestee.

The arrested accused namely Kalicharan Mondol (44 yrs) S/O- Lt. Gopal Mondol of Vill-Gopalpur, PS-Neturia, Dist-Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid (1) C/628 Giridhari Bauri (2) NVF/487 Kirtan Singh Sardar and (3) C/753 Shyam Sundar Mahato all are of Neturia PS accompanied me.

Under the above facts and circumstances, I therefore pray that a specific case may kindly be started against Kalicharan Mondol (44 yrs) S/O- Lt. Gopal Mondol of Vill-Gopalpur, PS-Neturia, Dist-Purulia under proper section of law.
