Respected Sir,

In producing herewith the accused Ganesh Rana (51 yrs) S/O- Lt. Budhan Rana of Vill-Bodma, PS-Mihijam, Dist-Jamtara, Jharkhand along with seized dumper bearing Registration No JH 13C/1336 loaded with quartz stone approx 400 cft under proper seizure list. The fact of the case in brief is that on the night of 27.05.2024, I along with C/332 Ashok Kumar Kandou and C/307 Sashanka Shekhar Boi both of Neturia P.S were engaged on night mobile duty at Neturia PS area vide Neturia PS GDE No- 1049 Dtd 27.05.2024 and CC No 1382/24 Dtd 27.05.2024. During mobile duty on 28.05.2024 at about 07.25 hrs received credible source information that the above noted dumper is coming from Barakar side towards Puapur side loaded with stone. After receiving this information we proceeded towards Gopalpur More under Neturia P.S. at 07.35 hrs and placed Naka at Gopalpur More under Neturia P.S and found that the above noted dumper was coming towards us. On seeing the Police party the driver of the said dumper stopped the dumper and tried to flee away. We rushed to the dumper and detain the driver at 08.55 hrs. We searched the said dumper and found that the dumper is loaded with quartz stone approx 400 cft. I asked the driver for any valid documents in respect of stone loaded in the dumper as well as the valid documents in respect of that dumper but he failed to produce any valid document in respect of stone and dumper. Hence I seized the dumper bearing Registration No JH 13C/1336 loaded with quartz stone under proper seizure list in presence of available witnesses duly signed by them in between 09.15 hrs to 09.35 hrs on 28.05.24 and arrested the driver of the vehicle NO- JH 13C/1336 namely Ganesh Rana (51 yrs) S/O- Lt. Budhan Rana of Vill-Bodma, PS-Mihijam, Dist-Jamtara, Jharkhand at 09.45 hrs. On interrogation the arrested driver stated that he loaded the said quartz stone from Badma village on direction of Swapan Kumar Das S/O- Lt. Bhabataran Das of Vill-Bodma, PS-Mihijam, Dist-Jamtara, Jharkhand. Accordingly I brought the said loaded dumper along with arrested driver to Neturia P.S. As such there is every reason to believe that the arrested driver, owner of the seized vehicle and Swapan Kumar Das S/O- Lt. Bhabataran Das of Vill-Bodma, PS-Mihijam, Dist-Jamtara, Jharkhand with ill motive are transporting the stone illegally without any valid document in support of carrying stone. So they are liable for offence punishable U/S - 379/411/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver, owner of the seized vehicle having registration No- JH 13C/1336 and Swapan Kumar Das S/O- Lt. Bhabataran Das of Vill-Bodma, PS-Mihijam, Dist-Jamtara, Jharkhand may kindly be started and arrange for its investigation.
