Sir,

In producing herewith the arrested accused person namely Pakhari Rajwar (45 Yrs) S/o- Lt. Buchu Rajwar of Vill- Surulia, PO- Vivekananda Nagar, PS- Purulia (M), Dist- Purulia and seized articles 18 (Eighteen) numbers of sealed bottles of 'DIL KHUSH' containing 600 ml each along with seizure list and Memo of Arrest.

I beg to state that today (01.05.2024) during my special mobile duty at about 19.05 hrs I, SI Soumen Kr. Panda of Purulia (M) PS received a secret tip off from an illegal possession of a huge quantity of liquor in a shop at Deer Park morh under Purulia (M) PS. Accordingly, I informed the matter to you and as per your direction myself along with force (i) C/- 564 Prasad Majhi & (ii) C/- 154 Rajib Nag all of Purulia (M) PS vide GDE No- 43 Dtd. 01.05.2024 rushed to the spot i.e. near Deer park morh at 19.35 hrs. After arriving at that spot and as per your instruction we conducted a raid in the suspected shop. During the raid some people managed to escape and we detained one person. On being asked, the detained person disclosed his identity as Pakhari Rajwar (45 Yrs) S/o- Lt. Buchu Rajwar of Vill- Surulia, PO- Vivekananda Nagar, PS- Purulia (M), Dist- Purulia. On being interrogated he confessed that he procured and stocked the said illegal liquors in his shop for selling illegally. So that he could gain more amounts from the selling of liquors. On demand he failed to produce any valid documents in respect of selling and possession of said liquors. Subsequently, I seized 18 (Eighteen) numbers of sealed bottles of DIL KHUSH C/S each containing 600 ml. In which 01 sealed bottle was taken as samples. I seized the same under proper seizure list in presence of witnesses and duly signed by witnesses and accused person. The seizure was made between 20.05 hrs and 20:15 hrs.

Accordingly, I arrested the involved accused person namely Pakhari Rajwar (45 Yrs) S/o- Lt. Buchu Rajwar of Vill- Surulia, PO- Vivekananda Nagar, PS- Purulia (M), Dist- Purulia at 20.25 hrs after maintaining all formalities regarding arrest after issuing Check List. Informed him regarding the ground of arrest and issued Memo of Arrest also issued Check List. The seized articles were properly sealed and labelled in presence of witnesses duly signed by them and the accused person.

Under the above facts and circumstances, I therefore, pray before you kindly take lawful action against the arrested accused person namely Pakhari Rajwar (45 Yrs) S/o- Lt. Buchu Rajwar of Vill- Surulia, PO- Vivekananda Nagar, PS- Purulia (M), Dist-Purulia under proper section of Law.
