Sub: Prayer for lodging FIR.

Sir,

In producing herewith the arrested involved driver namely Manojit Sengupta (27 Yrs) S/o- Sunil Sengupta of Vill- Balarampur, PO- Dabar Balarampur, PS-Purulia (M), Dist- Purulia along with seized vehicle (Tractor) having registration No- WB 55A 5497 attached with Trolley loaded with sand approx 100 cft, Seizure list, Memo of Arrest and Check List.

I beg to state that on 08.05.2024 I, SI Subrata Sarkar along with force (i) C/- 1111 Ragda Mandi (ii) C/- 531 Shib Shankar Mahanty & (iii) C/- 2505 Anup Kundu all of Purulia (M) PS left the PS for performing evening night mobile duty vide Purulia (M) PS GDE No- 406 Dtd. 08.05.2024 at PS area. During my mobile duty, at 23.15 hrs I received a tip off from my source that a suspicious tractor was loading sand at Balarampur Ghat of Kashai River. Accordingly, I informed the matter to you and as per your directions, I along with force proceeded towards that place to work out the information. Myself along with force, arrived at Balarampur Ghat area and kept the Govt vehicle at a distance proceeded to reach that place by foot. After arriving at that place at about 23.55 hrs we conducted a raid. During the raid we are detained one Tractor having Reg. No- WB 55A 5497 attached with Trolley, loaded with sand which was standing at that place. During the raid some people fled away and apprehended one person. On being asked, the apprehended person stated that he is the driver of said Tractor. He also disclosed his identity as Manojit Sengupta (27 Yrs) S/o- Sunil Sengupta of Vill- Balarampur, PO- Dabar Balarampur, PS- Purulia (M), Dist- Purulia. I asked the driver of the Tractor to produce valid documents in respect of the Tractor as well as the loaded sand. But the driver of the said Tractor was not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently at different times. The incoherent statement of the driver purported to be suspicious to us. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the Tractor by illegal means for selling the same to make their own profit by dishonestly and they had been running a clandestine business. So it is reasoned to believe that the alleged driver in cahoots with the owner of the Tractor procured the said sand from Balarampur Ghat of Kashai River by fraudulently or theft by any means for transporting the same to run clandestine business. So I seized the Tractor having Reg. No- WB 55A 5497 attached with Trolley, loaded with sand approx 100 cft under proper seizure list from Dabar Balarampur near Bridge in presence of available witnesses duly signed by them. The seizure was done on 09.05.2024 in between 00.05 to 00.25 hrs.

I also arrested the alleged driver namely Manojit Sengupta (27 Yrs) S/o- Sunil Sengupta of Vill- Balarampur, PO- Dabar Balarampur, PS-Purulia (M), Dist- Purulia maintain all formalities regarding arrest and NHRC guidelines after issuing Check list. Informing him the ground of his arrest and also informing his family members. The arrest was made on 09.05.2024 at 00.35 hrs. Thereafter, I brought the seized tractor and alleged arrested driver to Purulia (M) PS.

Under the above facts and circumstances I therefore pray before you kindly take lawful action against the owner and the arrested driver of seized Tractor having registration No- WB 55A 5497 namely Manojit Sengupta (27 Yrs) S/o- Sunil Sengupta of Vill- Balarampur, PO- Dabar Balarampur, PS-Purulia (M), Dist- Purulia under proper section of Law.
