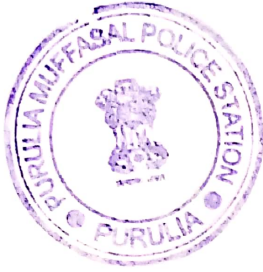
- 1) That, the petitioner is the permanent resident of the above noted address and within the jurisdiction of this Ld. Court at Purulia.

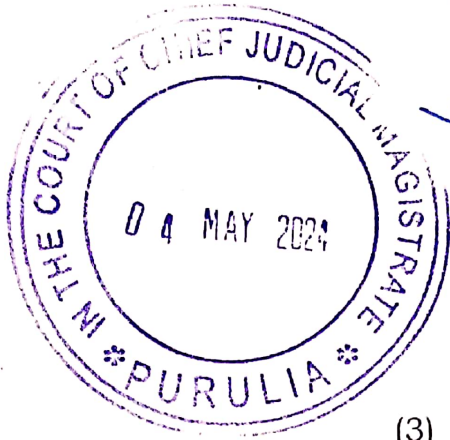

2) That, on 17/10/2023 at about 05.00 P.M when the husband of the petitioner namely Chuttulal Bauri was proceeding on one motor cycle bearing Registration No. WB-56G/3040 from Hura to Purulia and when he reached at Singhbazar Bharat petrol pump, under Purulia(M) police station at that time one another motor cycle bearing Registration No. WB-56R/2701 being driven in a rash and negligent manner of the driving by the driver of the said motorcycle dashed the motorcycle of the petitioner's husband as a result Chuttulal Bauri fall down from his motor cycle and grievously injured, immediately he was admitted at Deben Mahata Govt. Medical college & hospital at Purulia and the injury report was supplied by the hospital authority in which it is mentioned that the injury was taken place due to R.T.A and thereafter seeing the critical condition of Chuttulal Bauri the doctors referred him and so he was taken to Bokaro K.M Memorial hospital at Bokaro and thereafter he was admitted at Purulia New Maa hospital at Purulia and he died there on 30/10/2023 at about 08.30 hours.

3) That, the petitioner went to Purulia(M) police station to lodge the F.I.R against the driver of the offending motor cycle bearing Registration No. WB-56R/2701, but the police personnel denied to take any F.I.R.

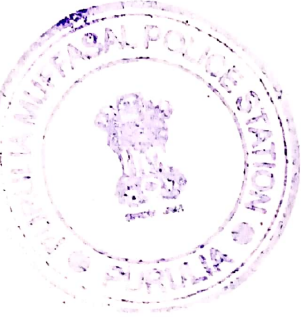
4) That, the complainant informed the matter to the superintendent of police at Purulia but still no action was taken against the accused persons.
