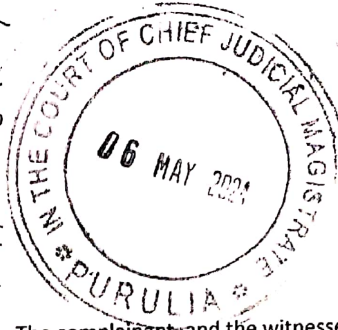
The petitioner / Complainant above named begs to state as under :--

1. That on 05.4.2024 at about 12 mid night, Falguni GOPE s/o. Late Subal Gope 2. Mangal Gope S/O. Dhiru Gope . and 3. Sunil Gope S/O LT. Buchu Gope of vill. Nadiara and about 15 other miscreants came to our house and started throwing bricks and stone .At that time the our family members were sleeping . Hearing their loud voice of filthy language we came out and called the local persons and they fled away.

Next day, on 6.4.2024 at about 12 noon the afore said miscreants caught fire the accumulated straw GADA which were destroyed completely. As a result the the petitioner's

family sustained loss of Rs. 1,00,000/-. The complainant and the witnesses saw the fire incident.

2. That the family of the complainant has milk business and for the cows they purchased the straw of Rs. 100,000/-

3. That the matter was reported to Purulia police station regarding the incident of 5.4.24 at about 11 A.M and thereafter regarding the incident of fire took place on 6.4.2024 was informed the matter before the Purulia (M).

4. That the said accused persons are influential persons in the locality, and no action was taken by the police concerned. The complainant informed the matter before the S.P., Purulia on 8.4.24.

5. That no action was taken by the police and hence the petitioner has been compelled to file the case against the said miscreants for legal action.

directing the O.C to investigate the case for the offence committed by the said accused persons so that they be punished
