Sub:- Report of theft.

Respected Sir,

This is to bring your attention that there is a tower in village Bagra, P.S. Purulia. In the landed property of Ramesh ch. Mahata and Baidyanath Mahata of Bagra. On 3.5.2024 night at about 1.25 hours the land owner Ramesh ch. Mahata realised that some culprit are committed theft in respect of tower articles. Then he called neighbours and surrounded the tower area and manage to catch one of the culprit. The culprit was interrogated by the public and the culprit disclose before the public he name and address as Rupak Mukherjee of Munsibdanga - P.S. and address as Purulia town. The culprit also disclosed that he along with another three persons came here to commit theft in respect of tower materials. Besides two motor cycle ride number WB 56 P/ 4802 and WB 56 R 1096 were found at the spot.

After that police was informed, police arrived at the spot and detained accused along with two motor cycle were handed over to the police. On 4.05.2024 during inspection and checking of the tower at Bagra by the subpost it was found that one part named 'AZANA MODULE' was not found which was fitted on the tower. So it is clear that the part name Azana module was taken away by the culprit named above and others on 3/05/2024 night at about 1.25 hour.

Under the above I request you to lodge a F.I.R, recover the articles of the investigation. So that accused be punished properly.
