Most respectfully begs to state:-

1...That the complainant and the accused persons are resident of village & P.O -
Raghampur under P.S. Purulia (M), District- Purulia (W.B) and within the
jurisdiction of this Ld. Court.

2...That on 25/04/2024 around 6.00 P.M while the minor daughter of the
complainant Debasmita (aged 10 years) went to purchase some utensils at nearby
grocery shop name and style as "BAPI GROCERY SHOP" and while she was returning
home suddenly a scooty (Model Honda Activa) most rash and negligently driven by
the accused person dashed her from backside, as a result she sustained serious
bleeding injury over her person and right leg was fractured and highly damaged.

3...That after knowing the incident the complainant rushed to the spot and took her
daughter to Purulia Deben Mahato Medical College and Hospital, but the attending
doctor of said medical college & hospital referred the injured daughter of the
complainant to the higher centre for better management . The daughter of the
complainant was admitted to Ranchi "Medanta Hospital" for her treatment and a

surgery was performed upon the right leg of the injured daughter of the complainant.

4...That the complainant later on came to know from co-villagers that the registered owner of the scooty is Durgadas Gorain S/O. Parikshit Gorain but they could not provide the registered number of the offending scooty as Durgadas Gorain is most influential person in the locality.

5...That the accident occurred due the rash and negligent driving by the accused person.

6...That the Complainant repeatedly went to Purulia (M) P.S. to lodge complaint against the accused person but the duty officer in table namely one Jayanta Babu refused to lodge complaint against the accused person rather started put pressure upon the complainant to settle the case after taking Rs. 30,000/- from the accused person when the complainant upon refusal by the complainant said Jayanta Babu (Sub Inspector) driven out the complaint from Purulia (M) P.S.

7...That having no alternatives the complainant sent his type complaint to the S.P. Purulia (M) P.S.

8...That on 9/05/2024 the complainant send his typed complainant to the I.C Purulia (M) P.S through registered post but till today no action has been taken against the accused person .

9...That 16.05.2024 the Complainant inform the matter to the S.P. Purulia but till date no action has been taken against the accused person as such having no other alternatives your Complainant filing this Misc. Petition u/s 156(3) of Cr.P.C. before this Ld. Court.

It is therefore prayed that your honour may graciously be pleased to admit this Misc. Petition filed u/s 156 (3) of Cr.P.C. and treating the same as a F.I.R. be pleased to send it to Purulia (M) P.S. with a direction to proper investigation and necessary steps against the accused person as alleged in the petition by the Complainant.
