This is to inform you that information received from your PS vide GDE No 1289 dated 21.05.2024 depleted the fact that three persons wearing costumes like SADHU are causing annoyance to the public by showing snakes. During working out on the information by ASI Bacchus Ghose of Purulia Town PS. 03(Three) Persons look like sage were detained with two snake (Wild life) in their possession from sahebbandh area on examination they were not able to show any documents for possession of such wild life. As a result they have been detained at Purulia Town PS with these two snakes for further proceeding. they disclosed their name and identity to Police as (1) Rajan (27 year approx) S/O Papu of R.K. Colony GT road Murthal,sonipat, Haryana 131039 (2) Garaknath (42 year approx) S/O Chabalnath of Plot No 29,KH NO -20 Dabar Enclave ,Raota Mod ,Raota Jaffarpur.Kalan, South West Delhi 110073 (3) Karambir Nath (38year approx) S/O Ghungru Nath of Jaffarpur Kalan.Dabar Enclave, south west Delhi 110073.

After physical verification it revealed that the persons have violated section 2, 9, 39, 40, 48, 49, 50, 51 and 50(1) of Wild life Protection Act,1972

Therefore you are requested to take appropriate legal action against them and handover the snakes to our department for rehabilitation .
