SUB:- Complaint against some unknown miscreants  
and persons who lent them.

Sir,

I beg to state that I am posted as a Lieutenant Colonel in Indian Army. Previously I was posted at 1032 Railway Engineer Regiment (TA) at Adra, Purulia. At that time one Neenu Bhoj cheated me and grabbed money from me and when I demanded back my money she lent some unknown hooligans and assaulted me and her family members also supported her in her misdeed. Over this issue I have filed a case in Judicial Magistrate Court at Raghunathpur and the said case is pending.

In the said case the date was fixed today i.e 20/05/24. Accordingly, I came yesterday at Raghunathpur. As soon as I reached Raghunathpur somehow Neenu Bhoj and her father namely Bhagwat Singh Bhoj and her mother namely Munni Bhoj and her brother namely Deep Prakash Bhoj got the information of my arrival at Raghunathpur and they called me over phone and began to put pressure to withdraw the case in default of which they threatened me with dire consequences, even today also after attending the court again Neenu Bhoj called me over phone and threatened me and misbehaved with me to the tune of threatening to implicate my parents in false cases.

Thereafter when I was going towards Joychandi hill area then some unknown miscreants came there and suddenly caught my collar and began to slap me. One of them assaulted me with stick on my hands and legs. The other miscreants caught my hair and were assaulting with fists and blows all over my body, while being assaulted in such manner I fell down on ground, then one of the miscreants sat on my chest and began to press my throat in order to kill me while other miscreants caught hold of my legs and hands. They also threatened me saying that if I do not withdraw the case against Neenu Bhoj, Bhagwat Singh Bhoj and Munni Bhoj then they will kill me when I will again come to Raghunathpur. They also threatened and directed me to do whatever was said by Neenu Bhoj and her brother Deep Prakash Bhoj and their parents over phone. The details of these four are as under:-

Sir, this is the second time that I have been assaulted by unknown hooligans sent by Neeru Bhoj and her family members but this time an attempt was made by them to get me killed. My life is in danger and I am feeling totally unsafe to come to Raghunathpur to attend my proceeding. In this context it is also pertinent to mention that in the case (89/2023) pending before Id JM Court at Raghunathpur, Non Bailable warrant of arrest is pending against Neeru Bhoj and her parents. I pray for justice and necessary action for my safety.
