In producing herewith 05 (Five) arrested persons, who disclosed their identities as (1) Gourab Bauri (28) S/o Rajen Ch. Bauri of Vill.- Kulur Bagicha, PS - Raghunathpur, Dist.- Purulia, (2) Tapas Paul (29) S/o Subhas Paul of Vill.- Godi Bero, PS - Raghunathpur, Dist.- Purulia, (3) Nibani Pal (41) S/o Lt. Shaktipada Pal of Vill.- Godi Bero, PS - Raghunathpur, Dist.- Purulia, (4) Chanki Barat (32) S/o Lt. Tribhanga Barat of Do and (5) Trilochan Bauri (48) S/o Lt. Jugal Bauri of Vill.- Kharbona, PS - Raghunathpur, Dist.- Purulia along with proper arrest memos in c/w above noted reference along with seized 02 (two) motorcycles bearing Reg. No. WB 82C/7750, WB 82F/094717 under proper seizure list, attached herewith I SI Sk Amanur of Raghunathpur PS do hereby lodge this complaint to the effect that today i.e. on 20.05.2024 at about 12:55 hrs having an information that some local people gathered on Raghunathpur - Bankura Road (SH -8) near Bero Bus Stand under Raghunathpur Police Station. After receiving this information I also informed this matter to my superiors and as per their direction I rushed to the spot with ASI Bipadtaran Chatterjee, ASI Barun Kr Das and ASI Biswajit Patra all of Raghunathpur PS vide Raghunathpur PS GDE No. 882 dated- 20.05.2024 and found that some male & female persons had blocked the road under the leadership of Daraknath Acherjee Goswami s/o Lt. Srinibas Acherjee Goswami of Bero PS Raghunathpur Dist Purulia. I asked them to disperse with loud and clear voice but they did not pay any heed to my words. We also tried to convince them but they did not pay any heed in our request. On being asked the above accused persons could not able to give any satisfactory answer for that movement on Raghunathpur - Bankura Road (SH-8) and blocked the public place. We started waiting and trying to convince them to clear the road for the interest of common people but our entire endeavor went air. They were willfully doing this blockade with an intention to injurious affect to the State Highway causing esteem inconvenience to common people violating our order without having any order either from any concerned authority. Finding no other alternative way, we drove them away by showing lathi. We able to apprehend the above noted accused persons. I arrested the above noted accused persons after maintaining all formalities regarding their arrest and seized 02 (two) motorcycles bearing Reg. No. WB 82C/7750, WB 82F/094717 under proper seizure list from there. We brought the above noted arrested accused persons along with seized motorcycles in PS.

Therefore I am requesting you to start a specific case against the arrested 05 (Five) accused persons, Daraknath Acherjee Goswami s/o Lt. Srinibas Acherjee Goswami of Bero PS Raghunathpur Dist Purulia and others under proper section of law and arrange for its investigation.
