Respected Madam,

I Smt. Mamoni Bouri, W/o Sri Kishore Bouri, (Panu Bouri) D/o Late Sumanta Bouri aged about 23 years, permanent resident of Village- Sidpur, P.S. Para, District- Purulia like to draw your kind attention on the following facts in respect of "Cruelty" and Harrashment upon me by my husband and his relatives for the last few years as such necessary legal action be taken against them.

1. That I have been married with Sri Kishore Bouri S/o Sri Robi Bouri as per the Hindu rites and custom on 20/4/2019 at Moutore Kali Mandir, P.S. Raghunathpur, District- Purulia. The said marriage still subsists.

2. That during the time of marriage my father gave a cash money of Rs. 50,000/- (Rs. Fifty thousand) gold, and silver ornament, utensil etc.

3. That after the said marriage I went to my matrimonial house at village- Sidpur and started to lead a conjugal life with my husband along with other family members which include, Husband, father in law, mother in law, sister in law (Nehad) etc.

That the dream of conjugal happiness evaporated when the accd. persons namely (1) Kishore Bouri (Husband) (2) Robi Bouri (father-in-law) (3) Chinta moni Bouri (mother-in-law) (4) Subarna Bouri (sister-in-law) began to harrashing me with a view to coercing to meet unlawful demand of Rs.50,000/- (Rs.fifty thousand) as additional dowry from my parents. All the accd. persons began to ill-treat and assault me on filmsy domestic lapses .I was denied square of meals and clean wearing apperals and in such state of affairs my health broken down but no medical assistance was given to me.

5. That due to aforesaid wed-lock I was blessed with one son namely Mongal Bouri aged 3 yrs. and a daughter aged about 16 months . Just after the birth of female child, torture and ill-treatment started again . My husband wanted to marry with another girl because of illicit reletion with her as such my husband wanted to drove me out from his house ~~for~~ on false ground and also for non payment demand of dowry ,of Rs.50,000/- as such my husband several times inform my parents to take me at their house. for non payment of additional dowry .

6. That even after such torture and harrashment I brooked all torture only to save my minor children~~s~~.

7. That when I refuse to left my matrimonial home all the accd persons assaulted me on 5/5/2024 causing injury on my person and on hearing the said incident my mother , maternal uncle and other relatives rushed to my matrimonial home, at Sidpur on 7/5/24 and ask them why they are torturing me, at that time all of them ^{Threaten} my relatives with dire consequences ,seeing the condition my mother and other relative brought me and my minor daughter to their house. At present I am compelling to take shelter in the house of my maternal uncle at Village- Kasparasara, P.O./ P.S. Chirkunda, District- Dhanbad (J.K.).

8. That at present I am passing my days with great difficulties .


In view of the fact and circumstance. I request you to kindly treat ~~my~~ my written complain as F.I.R. and take necessary action against the accd. persons.
