Sub : Prayer for lodging FIR against two accd. persons namely Somnath Rawani (28 yrs) S/o- Manbhul Rawani of Vill- Simultand and Motilal Soren (40 yrs) S/o- Fagu Soren of Vill- Uparbandha, Yogidih both of PS- Siyaljori, Dist- Bokaro, Jharkhand, U/S 46A (c) B.E. Act 1909.

Sir,

In producing herewith two arrested accused accd. persons namely Somnath Rawani (28 yrs) S/o- Manbhul Rawani of Vill- Simultand and Motilal Soren (40 yrs) S/o- Fagu Soren of Vill- Uparbandha, Yogidih both of PS- Siyaljori, Dist- Bokaro, Jharkhand, along with 50 bottles seized strong beer styled as "TUBORGS" 650 ml in each bottle and one block colour Hero Splendor Plus Motorcycle bearing registration number JH10BZ-1802. I beg to state that today i.e on 13.05.2024 at 16.25 hrs acting on a tip off I along with force had been to Pandey bandh near Poradih Junior High School. This refers to Santaldih I/C BCW GDE No- 231 and C.C No- 819/2024 of dated 13.05.2024. I along with force held raid at Pandey bandh near Poradih Junior High School under Santaldih PS. Seeing police van some unknown persons coming out from the jungle and fled away. However I could be able to intercept two persons namely Somnath Rawani and Motilal Soren with their motorcycle. On search found 50 bottles strong beer styled as "TUBORGS" 650 ml in each bottle with them. On asked they failed to produce any valid documents in respect of possessing and selling of beer as well as they confessed their guilt. Accordingly I seized and labeled 50 bottles strong beer styled as "TUBORGS" 650 ml in each bottle under proper seizure list in presence of witnesses duly signed by them. Out of seized bottles beer 01(One) bottle "TUBORGS" is kept as sample and one block colour Hero Splendor Plus motorcycle bearing registration number JH10BZ-1802. I also arrested both accused persons Somnath Rawani (28 yrs) S/o- Manbhul Rawani of Vill- Simultand and Motilal Soren (40 yrs) S/o- Fagu Soren of Vill- Uparbandha, Yogidih both of PS- Siyaljori, Dist- Bokaro, Jharkhand.

However the accd. persons Somnath Rawani and Motilal Soren committed offence U/S 46 A (c) B.E Act, 1909 for possessing and selling of beer without any valid documents.

Therefore, I pray before you that a case may be started against two accd. persons namely Somnath Rawani (28 yrs) S/o- Manbhul Rawani of Vill- Simultand and Motilal Soren (40 yrs) S/o- Fagu Soren of Vill- Uparbandha, Yogidih both of PS- Siyaljori, Dist- Bokaro, Jharkhand under proper section of law.
