Sub: Complaint against Jiten Mondal (53 Yrs) S/O-Lt. Satish Ch. Mondal of Santuri village, P.S - Santuri, Dist - Purulia to start a cog case U/S- 46A(C) B.E. Act 1909.

## Respected Sir,

In producing here with the arrested accused person namely Jiten Mondal (53 Yrs) S/O-Lt. Satish Ch. Mondal of Santuri village, P.S - Santuri, Dist - Purulia along with 15 (Fifteen) bottles Country Sprit styled as "Dil Se" each bottle containing 600 ml Dil Se seized under proper seizure list, I beg to submit that today (01.05.2024), I along with force while performing evening mobile duty at about 17:45 hrs received a credible source information that one person Jiten Mondal (53 Yrs) S/O-Lt. Satish Ch. Mondal of Santuri village, P.S - Santuri, Dist - Purulia was stocking and selling Country Sprit styled as "Dil Se" without any valid documents/license from his stationary Shop at Vill- Tilabaid, P.S - Santuri, Dist - Purulia. I informed to OC Santuri PS about this matter & as per direction, I along with force reached at his stationary shop of Jiten Mondal at about 18:10 hrs at Tilabaid village to work out the source information and held raid there. I like to note here that seeing the Police personnel, customers were fled away. During search with the help of accompany force, we found that the said person was stocking Country sprit styled as "DIl Se" for sell. On demand, he failed to produce any valid documents/ License in respect of selling and stocking of Country Sprit. Accordingly, I seized and labeled 15 (Fifteen) bottles country sprit styled as "Dil Se" containing 600 ml each bottle under proper seizure list duly signed by the witnesses out of which one bottle sealed and labeled as sample. Then, I arrested him after preparing proper arrest memo as he committed offence U/S- 46A(C) B.E. Act 1909 and supplied one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S- 46A (C) B.E. Act 1909 against the arrested accused person namely Jiten Mondal (53 Yrs) S/O-Lt. Satish Mondal of Santuri village, P.S - Santuri, Dist - Purulia.
