I, Milan Ch. Garain S/o- Laxmi Kanta Garain of Vill- Baragram, P.O- Napara Baragram, PS- Hura, Dist- Purulia, at present posted at Tamna PS, Dist- Purulia, as ASI of Police producing herewith one arrested accused person namely Dibakar Mahato (48 yrs) S/O- Lt. Gurupada Mahato of Vill- Bhadsa, PS-Tamna, Dist- Purulia with seized articles i.e. 1) One white colour plastic jerican containing approx 08 Ltrs. ID Liquor, 2) One Plastic Bottle containing 1 Ltr. I beg to submit that today (01.05.2024) during my PS area spl. mobile duty received a secret source information that one person is selling I.D Liquor in his house at Bhadsa village under Tamna PS, so myself along with i) C/138 Bani Bandhapadhyay & ii) C/195 Santosh Sing Sardar both of Tamna PS came to the spot at about 21:05 hrs and found that one person is selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehend the accused person namely Dibakar Mahato (48 yrs) S/O- Lt. Gurupada Mahato of Vill- Bhadsa, PS- Tamna, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1). One white colour plastic jerican containing approx 08 Ltrs. of ID Liquor, 2) One Plastic Bottle containing 1 Ltr. ID liquor as sample collected from seized articles from Sl No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Dibakar Mahato (48 yrs) S/O- Lt. Gurupada Mahato of Vill- Bhadsa, PS- Tamna, Dist- Purulia as per proper section of law.
