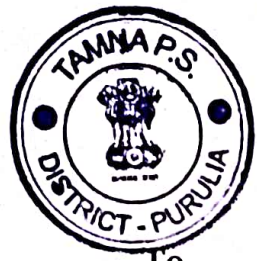

Respected Sir,

I, Anupam Chand S/o- Narayan Ch. Chand of Belguma Chandmaridanga, PS- Tamna, Dist- Purulia, at present posted at Tamna PS, Dist- Purulia, as ASI of Police producing herewith one arrested accused person namely Bhriguram Mahato (40 yrs) S/O- Lt. Bholu Mahato of Vill- Hinduhir, PS- Arsha, Dist- Purulia with seized articles i.e. 1) Three white colour plastic jericane containing approx 30 Ltrs. ID Liquor, 2) Three Plastic Bottle containing 3 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list.

I beg to submit that today (09.05.2024) during my PS area mobile duty received a secret source information that one person is selling I.D Liquor at Amchuria morh under Tamna PS, so myself along with i) C/67 Palash Patra & ii) C/2642 Mukunda Garai both of Tamna PS came to the spot at about 17:25 hrs and found that one person is selling I.D Liquor to the others. Seeing the Police party, all customers fled way but we managed to apprehend the accused person namely Bhriguram Mahato (40 yrs) S/O- Lt. Bholu Mahato of Vill- Hinduhir, PS- Arsha, Dist- Purulia. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such 1) Three white colour plastic jericane containing approx 30 Ltrs. ID Liquor, 2) Three Plastic Bottle containing 3 Ltr. ID liquor as sample which was collected from seized articles Sl No-01 which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Bhriguram Mahato (40 yrs) S/O- Lt. Bholu Mahato of Vill- Hinduhir, PS- Arsha, Dist- Purulia as per proper section of law.
