In producing here with one arrested accused namely Goutam Dey (45 yrs) S/O Lt. Bankim Dey of Palashkola, PS-Adra, Dist-Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 12 bottles DIL KHUSH country spirit, 300 Ml. each Rs/-35 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample.

I SI Tapas Chatterjee of Adra PS do here by lodged a complaint against accused namely Goutam Dey (45 yrs) S/O Lt. Bankim Dey of Palashkola, PS-Adra, Dist-Purulia to the effect that on 21/06/24 at about 20:05 hrs I received a information from a reliable source that one Goutam Dey has been stock of country spirit illegally at his Jhupri at Palashkola. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left Adra PS vide Adra PS CC No-1459/24 dtd.21.06.24. I reached at Palashkola at about 20:25 hrs and hold raid in the Jhupri of said Goutam Dey and found that the said person selling liquor at his Jhupri at Palashkola and after seeing the Police party some person fled away and said Goutam Dey has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Goutam Dey selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 20.25 hrs to 20.55 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Goutam Dey (45 yrs) S/O Lt. Bankim Dey of Palashkola, PS-Adra, Dist-Purulia under proper section of law.
