Sir,

In producing here with one arrested accused namely Sabna Malakar (59 Yrs) S/O Lt. Gorachand Malakar, of Panchudanga Hari Para, PS-Adra, Dist- Purulia along with following seized articles with seizure list and Memo of Arrest.

1) 10 bottles DIL KHUSH country spirit, 600 Ml. each Rs/-55 of each bottle out of them one bottle of country spirit taken from Sl. No. 1 duly sealed and labeled as sample.

I ASI Ajay Kumar Mandal of Adra PS do here by lodged a complaint against accused namely Sabna Malakar (59 Yrs) S/O Lt. Gorachand Malakar, of Panchudanga Hari Para, PS-Adra, Dist- Purulia to the effect that on 28/06/24 at about 18:35 hrs while performing special raid I received a information from a reliable source that one Sabna Malakar has been stock of country spirit illegally at his Jhupri/ Shop at Panchudanga Village. After getting such information I informed to my I/C and as per his direction I along with my accompanied force left for work out the information vide Adra PS CC No-1523/24 dtd.28.06.24. I reached at Panchudanga Hari Para at about 19:10 hrs and hold raid in the Jhupri/Shop of said Sabna Malakar and found that the said person selling liquor at his Jhupri/Shop at Panchudanga Hari Para and after seeing the Police party some person fled away and said Sabna Malakar has tried to concealed himself but I able to apprehend him with the help of accompanied force and also detained him. I asked him to produced valid License or valid papers for selling country spirit but he failed to produce any valid license or documents for possessing /selling the same. So it is sufficient reason to believe that said Sabna Malakar selling the country spirit by illegal way. I seized the above mentioned articles under proper seizure list duly sign by accused person and available witnesses and arrested the above mentioned accused person informing the ground of arrest. The complete process was done in between 19.10 hrs to 19.35 hrs.

Hence I there for pray that a specific case may kindly be started against arrested accused Sabna Malakar (59 Yrs) S/O Lt. Gorachand Malakar, of Panchudanga Hari Para, PS-Adra, Dist- Purulia under proper section of law.
